International Relations: Overview of activity, February 2024-31 August 2025

Executive summary

1. The following report contains an overview of activity of the International Relations Office during the period between 1 February 2024 and 31 August 2025. No SPCB decision is being sought.

Issues and options

Inward visits

- 2. Annexe A contains a full list of inward visits in the period of this report.
- 3. During the period 1 February 2024 to 31 August 2025, IRO delivered 81 inward visits. 13 of these were by Speakers of other legislatures, 13 by Ambassadors, 11 by Consuls/Consuls General, 16 by Parliamentarians and 28 by others, including officials from other legislatures.

4. This was a decrease of 18 visits from the previous 18 months. One of the reasons for the decrease in total visits was the low number of Ambassadors that visited the Scottish Parliament during this period. Ambassadors usually visit the Scottish Parliament once during their tenure; however, this of course depends on business needs for visiting Scotland.

Outward visits

5. **Annexe B** contains a full list of the outward visits in the period of this report.

6. During the period 1 February 2024 to 31 August 2025, IRO delivered 19 outward visits. Four of these were led by the Presiding Officer or a Deputy Presiding Officer, two just included Members, seven were in connection to the Commonwealth Parliamentary Association (CPA), three were in connection to the British Irish Parliamentary Assembly (BIPA) and three included officials only. This was a decrease of four from the previous 18 months.

7. One of the main reasons for the decrease was a reduction of BIPA meetings and plenary sessions due to the elections taking place in both the UK and Irish Parliaments.

Bilateral relations

- 8. IRO supports both inward and outward visits in order to deliver the International Strategy. Naturally, the most substantial engagement tends to be with those legislatures with which the Parliament has a historic relationship, those who proactively seek to engage with us, those that have similar size and characteristics, and those where there is potential for mutual benefit from working together.
- 9. As an example, the Scottish Parliament has strong relationships with the National Assembly of Québec. In June 2024 Mme Nathalie Roy MNA, President of the National Assembly of Québec, led a delegation to the Scottish Parliament. The delegation met with the Presiding Officer, Deputy Presiding Officers, Members and officials to discuss the role and functions of the Parliamentary Bureau, the work of the Gender Sensitive Parliament Advisory Group, cyber security and barriers to women entering politics.
- 10. Following this, in July 2025 the Scottish Parliament was invited to attend, as international guests, the 61st Canadian Regional Conference of the CPA and the Canadian Region Commonwealth Women Parliamentarians (CWP) Conference hosted by the National Assembly of Québec. Pam Duncan-Glancy MSP and Roz McCall MSP attended the conference on behalf of the Scottish Parliament and were able to further develop this bilateral relationship. Read the report of the 61st Canadian Regional Conference of the CPA and the Canadian Region CWP Conference.

11. Similarly, as a result of focusing on geographical areas and developing bilateral relationships, in April 2025 Deputy Presiding Officer Liam McArthur MSP led a delegation to visit the Faroese Parliament. Discussions included salmon farming, crime, labour market and the running of the parliaments. These were follow on discussions from previous meetings with Faroese delegations. In 2023 the Faroese Presidium visited the Scottish Parliament and met with the Presiding Officer, Members and officials; and in October 2023 Deputy Presiding Officer Annabelle Ewing MSP met with Johan Dahl, Second Deputy Speaker of the Faroese Parliament at the Nordic Council Session in Oslo. Multilateral relations

Westminster Foundation for Democracy (WFD) and the National Democratic Institute (NDI)

- 12. In addition to inward and outward visits, IRO has been focusing on developing strategic relationships with organisations such as the Westminster Foundation for Democracy (WFD) and the National Democratic Institute (NDI). By working with these organisations, which seek to strengthen democratic institutions around the world, the Parliament can engage in mutual learning with a wide range of parliaments and can provide continuous professional development opportunities for both Members and officials, one of the key elements of the International Strategy.
- 13. For example, in March 2024 the WFD sponsored a Post-Legislative Scrutiny focused visit in Nepal, which was attended by Martin Whitfield MSP. Read the report of the Post-Legislative Scrutiny visit in Nepal.

British Irish Parliamentary Assembly (BIPA)

- 14. The Scottish Parliament was admitted to the BIPA in February 2001 and has five full places and four associate places on the Assembly. IRO acts as the secretariat to the Scottish delegation and support MSPs in their work. In addition to bi-annual plenary meetings, Members participate in five committees which meet periodically throughout the year.
- 15. During the reporting period however, there was only one plenary session and two meetings of the Steering Committee. This hiatus in activity was due to the UK and Irish General Elections and the subsequent delay in nominating their respective memberships.
- 16. In Session 6, the delegation to BIPA is led by Deputy Presiding Officer Annabelle Ewing MSP. The remaining four Full Members comprise of Emma Harper MSP, Tess White MSP, Pauline McNeill MSP and Ross Greer MSP.

Commonwealth Parliamentary Association (CPA)

17. Since 2000 the Scottish Parliament has been a member of the Commonwealth Parliamentary Association. The Scottish Parliament (known as the Scotland Branch) is a member of the British Islands and Mediterranean Region (BIMR).

Governance

18. The Presiding Officer is the President of the Scotland Branch and all MSPs are members of the CPA Scotland Branch.

19. The CPA Scotland Branch Executive Committee in 2024/25 comprised Jeremy Balfour MSP, Sarah Boyack MSP and Stuart McMillan MSP.

Networks

- 20. The Scotland Branch is a very active member of the CPA and during the period 1 February 2024 to 31 August 2025 had regional representatives on three of four of the CPA Networks:
 - Jeremy Balfour MSP was the BIMR Champion on the <u>Commonwealth</u> Parliamentarians with Disabilities (CPwD) Network
 - Sarah Boyack MSP was the BIMR representative on the <u>Commonwealth</u> Women Parliamentarians (CWP) Network
 - Stuart McMillan MSP was one of the BIMR representatives on the <u>CPA</u> <u>International Executive Committee</u>
- 21. Also, since September 2024, Roz McCall MSP has been the Scottish Branch representative on the BIMR CWP Network Steering Committee together with Sarah Boyack MSP.
- 22. In June 2025 Jamie Greene MSP co-founded the CPA BIMR LGBT+ Network.
- 23. IRO started collecting statistics on CPA opportunities in September 2024. During the period 1 September 2024 to 31 August 2025 the Scottish Branch network representatives took part in 19 network meetings and events.

CPA activities

- 24. The CPA offers Members and officials various opportunities to get involved in their work including attending conferences, Election Observation Missions, webinars and training courses. The activities offer attendees professional development and knowledge exchange opportunities to enhance their skills as parliamentarians and share best practice.
- 25. From 1 September 2024 to 31 August 2025, 25 opportunities were presented to the Scotland Branch. Of these, the Scotland Branch Executive Committee offered 18 opportunities to Members and/or officials. As a result, 37 Members and one official took part in opportunities during this period (some opportunities offered multiple spaces).

Outcomes

27.IRO is keen to ensure that the benefit realised from both inward and outward visits is fed back into Parliament to ensure wider learning across the Parliament. All Members going on outwards are asked to provide feedback within three weeks of returning from an outward and again six months later. This enables IRO to understand what learning has been implemented across Parliament. Inward visits by delegations of parliamentarians and officials are sent an evaluation form to complete after their visit. Some examples of feedback from both inward and outward visits are provided below.

- 28. In June 2024 the States Greffier of Guernsey visited the Parliament to learn about how we support the Presiding Officer and said.
 - "The series of meetings were very well put together and I left much better informed about the workings of the Scottish Parliament and support for the Presiding Officer and have taken away many things to reflect on in respect of my own parliament. It was interparliamentary exchange at its best."
- 29. In April 2024 the Presiding Officer, Maurice Golden MSP, and Evelyn Tweed MSP visited the Legislative Assembly of British Columbia and New York City as part of Tartan Week. Maurice Golden said:
 - "The study tour helped me develop both professionally and as a parliamentarian. It was incredibly useful to meet experts in a range of fields from climate change to citizen engagement in addition to the Scottish diaspora and serving parliamentarians. I have utilised the information gleaned from several meetings in my role on the Citizen Participation and Public Petitions Committee..."
- 30. In June 2025 Jeremy Balfour MSP, Sarah Boyack MSP, Jamie Greene MSP and Stuart McMillan MSP attended the 54th British Islands and Mediterranean Regional Conference in Cardiff, Wales. Stuart McMillan said:
 - "Attending the regional conference in person is always important, not only because of the official programme but also because of the additional conversations that take place engaging and learning about other parliamentary systems...."
- 31. In July 2025 Pam Duncan-Glancy MSP and Roz McCall MSP attended the 61st Canadian Regional Conference of the Commonwealth Parliamentary Association and the Canadian Region Commonwealth Women Parliamentarians Conference in Québec, Canada. Pam Duncan-Glancy said:
 - "I learned so much! From practical tools to managing the job, to the commonalties of issues and concerns across the globe. I also learned a lot about the work and the huge value of the CPA. I will update my group on this experience, including by sharing these reflections."

Governance

32. IRO is responsible for the development and implementation of the International Strategy. While it facilitates most inward, outward and virtual international visits, it is not involved in every such engagement e.g. those undertaken by committees as part of an inquiry or by MSPs on cross party groups. This paper therefore does not reflect all international activity taking place, only that supported by the IRO.

33. The current International Strategy built on the experiences and practices applied by the Parliament in developing its international relations approach. The continued link of the Strategy to the Parliament's Strategic and Delivery plans and the focus on the procedural, corporate and policy interests of the institution allows the IRO to better plan activity, provides a more efficient link to resources and secures practical benefits.
