Committee Announcements: Session 6

This Fact Sheet lists all committee announcements made in the Scottish Parliament from the beginning of Session 6. It is arranged by date, with the most recent date first. It includes a link to the statement in the Official Report, the name and title of the committee member making the announcement, the committee reporting to the Scottish Parliament and the subject of the announcement.

Committee announcements were first used in October 2018. They were introduced as a result of the Commission on Parliamentary Reform's recommendation that committees be allowed to make significant or urgent announcements and set out the findings from recently published committee reports during chamber meetings. See recommendation R47 of the Commission on Parliamentary Reform Report for more detail. They were initially introduced for a trial period of 3 months from October – December 2018. This trial period was then extended and committee announcements were made permanent by a change to the Standing Orders of the Scottish Parliament on 11 June 2019, coming into effect on 3 September 2019.
