#### Other new and altered motions and amendments

- \*S5M-00686 Ben Macpherson: Scottish Entrepreneur of the Year—That the Parliament congratulates Douglas Samuel, chief executive of the Spartan Community Football Academy, on winning the EY Entrepreneur of the Year Scottish Award at Gleneagles on 23 June 2016; welcomes the award, which acknowledges his hard work in developing the Academy over the past seven years; recognises the new opportunities for more people to participate in the sport and recreational activities that the Academy provides; appreciates that the Academy pro-actively endeavours to have a positive impact on social targets such as health improvement, increased employment opportunities and crime reduction; welcomes the Academy seeking to strengthen community cohesion by becoming a focal point for a range of community-based activities and programmes; recognises the hard work of all of the volunteers and staff that support Douglas and the Academy, and wishes the Academy and all those involved every success for the future
- \*S5M-00685 Sandra White: Flourish House—That the Parliament welcomes the announcement of a £267,220 grant from the Big Lottery Fund's Investing in Communities Life Transitions programme to Flourish House Ltd; notes that the funding will enable Flourish House to employ two development workers to deliver activities that will increase the confidence, skills and employability prospects of people with enduring health concerns in the Glasgow area, and commends the team at Flourish House for their achievement in obtaining this funding.
- \*S5M-00684 Sandra White: Awards for All Glasgow Kelvin—That the Parliament welcomes news that seven organisations in Glasgow Kelvin have recently received grants totalling £63,956 from the Awards for All Scotland programme; notes that the Scottish Refugee Council received £8,996 to fund a project worker, volunteer training and expenses in order to increase and raise the awareness of volunteering for its users and the benefits that it can bring in later life, that the Scottish Alliance of Regional Equality Councils Ltd has been awarded £10,000 to provide research on hate crime and the support that people who have experienced hate crime receive and that Show Racism the Red Card received £9,072 to deliver workshops on LGBTQI bullying for young people participating in community sport programmes; welcomes the £10,000 received by Thornwood Primary Parent Council to purchase new play equipment for the school's playground; notes that the Chinese Community Development Partnership Ltd received a £8,196 grant to establish a Mandarin-specific information, support and advocacy service for the Chinese

community in Glasgow; understands that Pancreatic Cancer Scotland will use its £8,800 grant to establish volunteer-led awareness stands on pancreatic cancer in acute NHS settings around Scotland and support groups for people who are affected or have been affected by pancreatic cancer; welcomes the £8,892 awarded to Yogability due to high demand to expand its provision of free therapeutic yoga sessions for disabled children, young people and adults and those with additional support needs, and wishes the organisations, their staff and volunteers every success.

- \*S5M-00683 Sandra White: Profound and Multiple Impairment Service—That the Parliament welcomes news that the Profound and Multiple Impairment Service has secured a grant worth over £98,000 from the Big Lottery Fund's Medium Grants Scotland programme; notes that the service will use the funding to provide person and family-centred support to 20 people with profound and multiple learning disabilities aged 15 to 18 from Glasgow, Renfrewshire and East Dunbartonshire who are leaving secondary education, and commends the Profound and Multiple Impairment Service on its hard work and commitment in obtaining this funding.
- \*S5M-00682 Sandra White: The Marie Trust—That the Parliament welcomes the announcement of a £613,666 grant from Big Lottery Fund's Investing in Communities Life Transitions programme to The Marie Trust in Glasgow; notes that the project will be delivered in partnership with Glasgow Kelvin College in response to a significant increase in demand by supporting individuals who are affected by homelessness and multiple barriers to moving on, such as addiction, offending and mental ill-health; further notes that the project will help people to sustain tenancies, reduce the likelihood of reoffending and gain qualifications, and commends The Marie Trust staff, volunteers and supporters for their commitment and determination.
- \*S5M-00681 Sandra White: National Deaf Children's Society—That the Parliament welcomes news that the National Deaf Children's Society received a £445,202 grant from the Big Lottery Investing in Communities Supporting 21st Century Life fund; notes that this project will offer a comprehensive support package for deaf children up to eight years old and their families and will use an early intervention approach to increase opportunities for deaf children, as well as developing skills and confidence in their families, and commends the National Deaf Children's Society on its work and its success in securing this funding.
- \*S5M-00680 Sandra White: Palestine Youth Orchestra—That the Parliament welcomes the first ever performance in Scotland by the Palestine Youth Orchestra; notes that the performance at the Glasgow Royal Concert Hall on 26 July 2016 will follow a rehearsal residency at the Royal Conservatoire of Scotland and is part of the International Society of Music Education, which runs from 18 to 24 July; understands that the orchestra was established by the Edward Said National Conservatory of Music in 2004 with the vision of bringing together talented students from all over Palestine and the Palestinian diaspora to perform both Western and Arabic music; commends the orchestra's drive and passion for music, and wishes its members every success on their tour, which they hope will bring a message of inspiration and humanity to audiences.
- \*S5M-00679 Rhoda Grant: Support for Scottish Farming—That the Parliament congratulates NFU Scotland on getting commitments from some supermarkets to increase their support for home-produced lamb; notes its campaign to secure greater support for Scottish and British pork products; further notes the environmental benefit of sourcing local products, and acknowledges that Scottish produce is a source of safe, tasty and nutritious food.

\*S5M-00678 Lewis Macdonald: Katherine Grainger Selected for Fifth Olympic Games—That the Parliament congratulates Katherine Grainger and her rowing partner, Victoria Thornley, on being included in the Team GB squad to take part in the double scull event at the 2016 Olympic Games in Brazil this summer; recognises that Katherine is Britain's most decorated female Olympian, with three silver medals from Sydney 2000, Athens 2004 and Beijing 2008 and a gold medal in the double sculls from London 2012, making her the defending champion in the event at Rio 2016; further recognises that Katherine, who was raised in Aberdeen and has a gold post box on the city's Castlegate to mark her victory at London 2012, will be competing in her fifth Olympics in Rio, and wishes her and Victoria and all the Team GB rowing squad all the best for a successful Olympic Games.

\*S5M-00677 Lewis Macdonald: Margaret E Morrison Spirit of the Community Awards—That the Parliament congratulates the winners of the Margaret E Morrison Spirit of the Community Awards, which were announced at Inchgarth Community Centre in Aberdeen on 24 June 2016; understands that the awards recognise those who have enriched local communities and the city by giving their time in order to make a difference to the lives of others; congratulates the winners, George Stewart, recognised for his contribution to boxing in Garthdee, Lizzie Thomas of the Cults O50 Club, Chris Fraser of Cairncry Community Centre, Lesley Knowles and Louise Baxter who were recognised for their work with disabled people, Rick Brooks, director of the charity TLC, hairdresser Heather Dalgarno, recognised for her work with cancer charities and Margaret Vieira who received her award for her service to the communities of Cove and Altens; understands that the ceremony was attended by almost 400 people including the city's Lord Provost, and commends all the winners of the awards on their achievement.

\*S5M-00676 Lewis Macdonald: First Anniversary for Big Noise Torry—That the Parliament congratulates the Aberdeen music project, Big Noise Torry, on its first anniversary; recognises that the £2 million music project, run by Sistema Scotland with funding from Aberdeen City Council, is based in the Torry area of the city and provides general musical tuition for Primary 1 and 2 pupils while Primary 3 pupils are taught to play instruments by professional musicians; understands that the six-year project has already reached dozens of pupils at Tullos and Walker Road primary schools and that the next stage will be the provision of musical tuition for babies and toddlers; notes that a special concert performance was given by members of Big Noise Torry to celebrate the first anniversary, and looks forward to the initiative going on to further success in the city.

England and Wales have set drug driving limits that allow the police to target drug drivers more efficiently and effectively and that, as a result, the detection of drug driving offences has increased from 52% in 2012 to 95%; believes that Police Scotland has to use the five-point practical field impairment test when officers suspect that someone is driving under the influence of drugs; notes that a consultation in Scotland on this issue was completed in July 2015, and recommends that, to make the country's roads safer, the Scottish Government should introduce drug driving limits.

\*S5M-00672 Richard Leonard: Stop the Europark Development Campaign—That the Parliament is deeply concerned about a Proposal of Application Notice from the developer, Orchard Brae Ltd, to build 3,000 houses and other retail and commercial uses on greenbelt between Calderbank and Carnbroe in North Lanarkshire; believes that such a development would be a clear breach of the Scottish Government's policy on greenbelt as set out in the Scottish Planning Policy, paragraphs 49 to 52, and welcomes the formation of the Stop the Europark development campaign.

\*S5M-00671 Gil Paterson: St Margaret of Scotland Hospice, Above and Beyond—That the Parliament congratulates St Margaret of Scotland Hospice for its commitment and dedication to the people of Clydebank and beyond; understands that the hospice is Scotland's oldest and largest with a team of 150 full- and part-time staff and countless volunteers; believes that, throughout its time, the hospice has offered compassion, dedication, commitment and excellent care to people who have advanced life-limiting illnesses and to older people with complex medical and nursing needs; understands that it offers a wide range of facilities to the local and wider community, including the Edwina Bradley Day Hospice, outpatient facilities and home care and counselling services; recognises that, for the third time running, the hospice has been graded as excellent in all categories by Healthcare Improvement Scotland, and believes that its AAA rating outstrips the UK AA rating and is a wonderful result for the hospice Chief Executive, Sister Rita Dawson, and the hospice board, and is a further indicator of their continued devotion to their patients and families, as well as the community.

\*S5M-00670 James Dornan: Impact of EU Referendum Result on Higher Education—That the Parliament recognises the significant and direct effects that the result of the EU referendum will have on Scotland's 19 higher education institutions, their staff and students; welcomes the reassurances given by the First Minister to European citizens living here that Scotland is their home and that their contribution to Scottish society is valued; stresses the value that Scotland continues to place on the contribution made by over 4,500 staff and 24,000 students from the EU who work and study in the higher education sector; is very concerned at the implications that Brexit now poses for continued opportunities for student mobility, attracting talent that furthers teaching and research excellence, the quality of research, which is known to have a greater impact when internationally co-authored, and access to important research funds, such as over £636 million to Scotland in the period 2007-13, that focus on shared societal challenges including dementia, other major health conditions, climate change and productive seas, and calls for crossparty support to secure the best possible outcome for Scotland's higher education institutions from the negotiations resulting from the referendum result, including prioritising the right for staff and students from EU countries to continue working and studying in Scotland and negotiating access to European programmes for students, staff and research.

The last lodging day for amendments at Stage 2 is three sitting days before the meeting at which those amendments will be considered (e.g. Thursday for a meeting on Tuesday); at Stage 3 it is four days before. Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for Stage 2, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
