*S5M-00853 Christina McKelvie: Children in Detention Centres—That the Parliament is deeply concerned at the announcement by the Minister of State for Immigration on 21 July 2016 regarding the closure of Cedars, which is a removal detention centre that is run by Barnardo's; regrets that it will be replaced by a so-called discrete unit at the Tinsley House Immigration Removal Centre without, it understands, input from the charity or other partners concerned with the welfare of children; believes that this will result in the unwarranted detention of children; considers detaining children to be a dangerously short-sighted and counterproductive practice that will place them in detached and isolating environments; believes that a humane immigration system should not result in children being held behind bars, and calls on the UK Government to rethink this proposal immediately and to ensure that children are not detained in this manner.

*S5M-00849 Andy Wightman: Edinburgh Airport Consultation—That the Parliament understands that Edinburgh Airport Limited (EAL), which owns 372.8 hectares of land in Lothian and is ultimately owned by companies in Grand Cayman and Luxembourg, has launched a 14week consultation that will close on 12 September 2016 regarding future airspace usage across Lothian, Falkirk and Fife; understands that there are fewer flight movements today than in 2006 and less freight tonnage than in 1997; is concerned that, given the timescale, communities could face challenges in being able to respond to the consultation and believes that there is very little justification for having it while the Civil Aviation Authority and the Department for Transport are reviewing the Guidance on Airspace Change Processes and Guidance on Environmental Objectives; is concerned that the 2015 TUTUR Edinburgh flight path trial resulted in significant changes in flight path usage and associated environmental impacts that should not be used as the baseline for the consultation; understands that historical flight path data is not being made available to the public; is sceptical of the case for more capacity, given the trends in flight movements and the likely impact on carbon emissions, and urges EAL to pause the consultation until the revised guidance is available, ensure that partners in the consultation are adequately resourced and to base it on a more appropriate baseline of flight path data.
