*S5M-00335 Kenneth Gibson: Living with Endometriosis—That the Parliament recognises the impact of endometriosis on the lives of the 10% of women of reproductive age, including a significant number in Cunninghame North and across Scotland, who are believed to have the condition; notes that it can be exceptionally difficult to diagnose, with the average time for diagnosis after the first symptoms being experienced understood to be 7.5 years; acknowledges that it causes physical pain and can lead to infertility and depression; believes that, although Endometriosis UK has stated that it is the second most common gynaecological condition, there is not enough debate and awareness about it, and notes the view that urgent work is required to see what can be done to achieve both earlier diagnosis and better treatment options for the many women in Scotland and beyond with endometriosis.
