Members' Business motions that have achieved cross party support

***S5M-00570 Sandra White: World Sickle Cell Day 2016**—That the Parliament notes that World Sickle Cell Day, which aims to raise awareness of the rare genetic condition, sickle cell disorder (SCD), will take place on 25 June 2016; understands that around 210 people in Scotland, the majority of whom are of African or Caribbean descent, have SCD; recognises the valuable work of organisations such as Sickle Cell Thalassaemia Support Group Scotland and the ACWA (African and Caribbean Woman's Association) in raising awareness through providing education about SCD, including helping to build an increased understanding of the pressures that the condition brings to people with it and their families; notes the pain and distress that SCD can bring in a "crisis situation", which is when it causes an inhibition of haemoglobin; understands that this can lead to depriving sections of the body of oxygen, which could result in organ damage; welcomes the recent £4 million investment by the Scottish Government in the Scottish Genomes Partnership (SGP), which will allow crucial research to be carried out into rare genetic disorders; understands that a goal of the SGP is for such conditions to be diagnosed and treated with greater speed and efficiency, and hopes that World Sickle Cell Day 2016 is a great success in the continued promotion and education of the disorder in Glasgow and across Scotland.

***S5M-00565 Miles Briggs: Opposition to Centralisation of Cleft Lip and Palate Surgery**—That the Parliament expresses its concern at the decision by NHS board chief executives on 21 June 2016 to approve the recommendation of the National Specialist Services Committee to centralise cleft lip and palate surgery in Glasgow; is aware that cleft lip and palate surgical services are currently provided at both the Royal Hospital for Sick Children, Edinburgh and the Royal Hospital for Children, Glasgow; considers that the Edinburgh team delivers a world class service with high quality care and is aware that the audited outcomes for children following surgery in Edinburgh are extremely high; notes that the Edinburgh unit currently provides care for children living all across eastern Scotland; is aware of concerns among parents and clinicians about the consultation process for this proposed centralisation and that more than 5,700 people

have signed an online petition opposing the plans; is further aware that the Cleft Lip and Palate Association (CLAPA) has spoken out about the lack of evidence to show that the existing two-site model is not working; is further aware that the Edinburgh unit is due to host the International Congress on Cleft Lip/Palate and Related Craniofacial Anomalies in 2021, and notes calls, given the level of concern among patients, parents and clinicians, for the Cabinet Secretary for Health and Sport to intervene and pause the centralisation plans to allow further consideration and to ensure that the specialist expertise, knowledge and care that has been built up in Edinburgh is not lost.
