#### Members' Business motions that have not achieved cross party support

\*S5M-00578 Stuart McMillan: Eye Health Week—That the Parliament marks Eye Health Week, which runs from 19 to 25 September 2016; believes that, since the World Health Organization has suggested that 50% of sight loss is preventable, a greater sense of urgency is needed with regard to eye health; is concerned that an ageing population, increases in diabetes and poor diet might contribute to a doubling of the number of visually impaired people in Scotland over the next 20 years; welcomes the continuation of free eye health checks; further welcomes what it believes is vital Scottish Government planning and investment for the long-term to contain sight-threatening diseases and the government's commitment to public eye health campaigns, especially among vulnerable groups where there are reports of low awareness about free eye health checks; understands that these include the lower socio-economic groups, ethnic minority groups and people at high risk through associated health conditions, and thanks the country's eye health professionals, RNIB Scotland, Optometry Scotland, the Scottish Council on Visual Impairment, community-based societies for blind people, Guide Dogs and other third sector organisations for the hard work that they do to support people with sight loss in Greenock and Inverclyde and across Scotland.

\*S5M-00577 Angus MacDonald: Pupil Power Secures Fairtrade Status for Bo'ness—That the Parliament congratulates Bo'ness on becoming the latest recognised Fairtrade Town, through the efforts of pupils from Bo'ness Public Primary School P5 class, their parents and their teacher, Alan Potters; considers that, by challenging the community, retailers and eateries in Bo'ness to commit to fairtrade values, community spirit has been a major factor in helping farmers in developing countries get a fairer deal for their produce; further considers that experience in organising fairtrade breakfasts and pop-up fairtrade shops in the primary school and around Bo'ness town centre has been vital in giving pupils a sense of responsibility towards helping those in developing countries and a sense of ownership of the values that Scotland has in helping people in challenging environments; recognises that Bo'ness becoming a Fairtrade Town is part of a wider network of 1,500 communities worldwide taking practical steps to make a fairer world trade system a reality, and commends P5 at Bo'ness Public Primary School for driving their community to achieve this recognition.

\*S5M-00576 Kenneth Gibson: Stop Albino Killings in Malawi—That the Parliament calls on the Malawi Government to take action in protecting its citizens with albinism, which is a rare, genetic condition that results in a lack of pigmentation in the hair, eyes and skin; understands that, recently, 18 albino people in Malawi have been abducted and killed and dozens of others have disappeared; further understands that there has been little to no intervention from the police to find the perpetrators; believes that people with albinism have faced discrimination in Malawi for years; is concerned that the 10,000 with the condition face an existential threat and are living in a state of constant fear for their lives due to the superstitious belief that their organs and body parts can be used to bring wealth and cure disease; considers this a deplorable act of barbarism; agrees with Amnesty International in asserting that the Malawi Government has failed to protect albino people; notes the longstanding relationship that Scotland has had with Malawi and calls for more awareness to be spread by addressing and confronting false beliefs and superstitions; further calls for justice to be served to the people carrying out these crimes, and urges both the Scottish Government, and the Commonwealth Parliamentary Association Scotland Branch, to persuade the Malawi Government to protect people with albinism from future attacks.

As soon as a Public Bill (i.e. a Government, Committee or Member's Bill) has completed Stage 1, amendments for consideration at Stage 2 may be lodged; and as soon as Stage 2 is completed, amendments for Stage 3 consideration may be lodged. The last lodging day for amendments at Stage 2 is three sitting days before the meeting at which those amendments will be considered (e.g. Thursday for a meeting on Tuesday); at Stage 3 it is four days before. Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for Stage 2, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
