Land and Buildings Transaction Tax (Amendment) (Scotland) Act 2016 (asp 11) received Royal Assent on 24 March 2016.

Budget (Scotland) Act 2016 (asp 12) and Scottish Elections (Dates) Act 2016 (asp 13) received Royal Assent on 30 March 2016.

Health (Tobacco, Nicotine etc. and Care) (Scotland) Act 2016 (asp 14) received Royal Assent on 6 April 2016.

Higher Education Governance (Scotland) Act 2016 (asp 15) received Royal Assent on 13 April 2016.

Lobbying (Scotland) Act 2016 (asp 16) and Scottish Fiscal Commission Act 2016 (asp 17) received Royal Assent on 14 April 2016.

Land Reform (Scotland) Act 2016 (asp 18) and Private Housing (Tenancies) (Scotland) Act 2016 (asp 19) received Royal Assent on 22 April 2016.

Burial and Cremation (Scotland) Act 2016 (asp 20), Bankruptcy (Scotland) Act 2016 (asp 21) and Abusive Behaviour and Sexual Harm (Scotland) Act (asp 22) received Royal Assent on 28 April 2016.
