#### Members' Business motions that have not achieved cross party support

\*S5M-00113 lain Gray: Closure of RBS Prestonpans Branch—That the Parliament notes with concern the proposed closure of the RBS branch in Prestonpans on 9 August 2016; understands that this will leave RBS customers without a branch in the town and with a trip to either Tranent or Musselburgh for their nearest branch; is unaware of any effort made by the bank to consult the local community and that RBS cites an increase in online and mobile transactions as a contributing factor to the closure; believes that this is unfair to many customers who have been loyal to RBS over the years particularly older customers and those without access to the internet who will be most affected by the closure, and notes calls for the bank to reconsider this decision and put the needs of its customers first.

#### Other new and altered motions and amendments

\*S5M-00126 Ben Macpherson: UK Government's Proposal to Scrap the Human Rights Act—That the Parliament notes with concern the UK Government's proposal to scrap the Human Rights Act 1998; believes that human rights are a crucial part of a democratic society; notes that the abolition of the Act would require the consent of the Scottish Parliament, and believes that such consent should be refused.

\*S5M-00125 John Mason: UN Calls on Turkey to Allow Observer Access to Kurdish Areas—That the Parliament notes the reports that the UN Human Rights Commissioner, Zeid Raad al-Hussein, has urged Turkey to grant the UN unimpeded access to the areas in the mainly Kurdish south-east of the country that are affected by fighting; is concerned by the commissioner's accounts of unarmed civilians, including women and children, being shot by snipers during the crackdown; understands that government forces have brought huge damage to the area's

infrastructure, and urges the Turkish Government to allow international observers full access to ensure the observation of human rights, by both sides, at all times in the conflict.

\*S5M-00124 Graeme Dey: Arbroath Ladies Lifeboat Guild—That the Parliament welcomes the outstanding fundraising efforts undertaken by the Arbroath Ladies Lifeboat Guild, with £46,200 being raised during 2015, including £23.028 from the guild's own efforts; notes that its recent annual general meeting was Barbara Cargill's last as president; further notes that Barbara was recently presented with a Local Hero award by the Festival of Heroes and that such awards were also given to the Arbroath Lifeboat itself and crew members with five years or more of continuous service; notes that, over the time that Barbara has served as president of the guild, it has raised in the region of £750,000, and commends the bravery of all of those who volunteer as lifeboat crew and the efforts of those who fundraise to support the service.

\*S5M-00123 David Torrance: Congratulations to Fair Isle Primary School—That the Parliament congratulates Fair Isle Primary School in Kirkcaldy on being the first school in the UK, and only the third in Europe, to be awarded Lighthouse status by the Leader in Me programme; notes that this achievement demonstrates that it has completed the full implementation process and has been designated as a model school; understands that this project aims to help children develop essential life skills, including critical thinking, goal setting, creativity and teamwork, and to inspire self-confidence; believes that, since the inception of this programme in the school three years ago, it has become an integral part of daily life for the pupils; commends its engagement with this whole-school improvement programme, which it believes will have a positive impact on both pupils and staff, and wishes the school continuing success.

\*S5M-00121 Sandra White: Glasgow 2016 Homelessness World Cup Legacy Project—That the Parliament congratulates Glasgow Life on its recent award of £343,383 from the Big Lottery Fund to help establish a lasting legacy from the July 2016 Homeless World Cup in Glasgow; believes that it will use the money to work in partnership with Glasgow City Council's social work team and the Glasgow Homelessness Network to recruit and train 200 people to volunteer in a variety of roles, on and off the pitch; understands that up to half of the volunteers will be people who have been homeless at some point in their lives; hopes that this legacy project will help them gain new skills and confidence through a post-games programme of sports coaching and creative writing; understands that the initiative will also allow people who have experienced homelessness to share their stories and reconnect with their communities; notes that this will be accompanied by a national media campaign that will be aimed at challenging some of the myths and misconceptions about homelessness, and encourages anyone who is interested in more information on the 2016 Homeless World Cup to visit homelessworldcup.org.

\*S5M-00120 Mary Fee: Renfrew FC Promotion Success—That the Parliament congratulates Renfrew FC on the team's success in winning the SJFA Central League First Division; recognises the hard work of all of the club's players and volunteers and their continued and unrivalled dedication and commitment; notes that this achievement means that the team has been successful in winning silverware in its first year at its new stadium, New Western Park, and wishes the players every success for next season in the Super League First Division.

\*S5M-00119 Neil Findlay: RBS Abandons Communities while the Chief Executive Scoops Millions—That the Parliament considers appalling the decision by RBS to axe another 200 jobs by closing yet more branches, including those in West Calder and Broxburn; notes that RBS, which is 73% owned by the taxpayer, has cut around 1,350 posts out of a workforce of 12,000 staff in its branch network since mid-March 2016; is astonished that the bank has reported an eighth successive year of losses, with a £2 billion loss the latest recorded, yet at the same time its chief executive, Ross McEwan, has been awarded a pay deal of £3.8 million, and believes that this is yet more evidence that there is one rule for workers and communities and another for the protected elite who have overseen years of poor performance yet still receive massive financial reward.

\*S5M-00118 Jackie Baillie: Closure of RBS Alexandria Banch—That the Parliament notes with concern the proposed closure of the RBS branch in Mitchell Way, Alexandria, on 15 August 2016; understands that the closure was announced without any prior consultation with RBS customers in the Vale of Leven, who will have to travel to Dumbarton to visit their nearest branch; notes that RBS has cited a decrease in the number of transactions taking place at the branch as one of the reasons for the closure; believes that the decision is short-sighted in light of West Dunbartonshire Council's announcement of a £6.5 million regeneration plan for Mithcell Way, which aims to boost retail by bringing shoppers back to the town centre and increasing footfall, and calls on RBS to reconsider the decision and pause the closure plans until it has fully consulted its loyal customers in Alexandria.

\*S5M-00117 lain Gray: Muirfield Golf Club—That the Parliament notes with disappointment the result of Muirfield Golf Club's vote on whether to admit women golfers as members; understands that the club required two thirds (432) of its 648 eligible voters to back the move, however, despite the 64% of those voting in favour of the resolution, the vote fell just short of the required two thirds majority to change club rules; believes that every golf club in Scotland has a duty to be inclusive and reflect modern society and that to do so clubs need to be open to both male and female golfers; considers that the decision was disappointing for equality and will also have a detrimental impact on East Lothian and its local economy through the loss of the opportunity to host major competitions such as the Open, and believes that the club should consider the decision again at the earliest opportunity.
