S5M-02355 Shona Robison: Scotland Values its EU Workforce and their Contribution to Health and Social Care—That the Parliament believes that Scotland's interests are best served by protecting its existing relationship in Europe, maintaining membership of the single market; recognises the valuable contribution that health and care staff from across the EU, and beyond, make to Scotland; notes that around 1 in 20 NHS doctors in Scotland come from other parts of the EU; resolves to continue promoting Scotland as a welcoming place for Europeans to work in the health and social care sector; is concerned that the outcome of the EU referendum will make it harder to recruit and retain EU citizens to work in health and care services in Scotland, and to study medicine, nursing and dentistry here; deplores the potential threat that Brexit poses to social and employment protection, which are vital to NHS staff; demands that the UK Government stops using NHS staff from the EU as "bargaining chips", and calls on the UK Government to ensure that Scotland is fully involved in decision-making, and in all negotiations between the UK Government and the EU to protect the interests of the health and social care workforce in Scotland.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
