***S5M-01334 Stuart McMillan: Stepwell Consultancy Inverclyde Receives Funding to Tackle Food Poverty**—That the Parliament congratulates Stepwell Consultancy in Inverclyde, which has received a share of £900,000 of Scottish Government funding along with 20 other organisations as part of the first wave of the Fair Food Transformation Fund, which will help initiatives across the country that are seeking to reduce reliance on emergency food aid by establishing more sustainable approaches to ensuring that families can access healthy, nutritious food; considers that Stepwell is an innovative social enterprise, committed to improving health, wellbeing and employment opportunities for vulnerable people living in the Inverclyde area by providing cook schools, d-stress classes and a range of other social impact services that help to improve health and wellbeing and increase self-confidence, motivation and future aspirations of individuals who have found themselves in difficult life circumstances; recognises that this approach is a shift away from dependence on emergency foodbanks to a more collective approach that helps people find a community solution to an ongoing problem; believes that community-based initiatives, such as Stepwell, where people are supported in a dignified way and where the underlying causes of food poverty can be addressed, should be encouraged across Scotland, and notes that the Scottish Government will continue to work closely with projects to help them develop and build sustainable solutions to tackle food poverty across Scotland.
