S5M-07735 Alexander Stewart: Brain Tumour Awareness in Scotland—That the Parliament understands that brain tumours are the biggest cancer killer of children and adults under the age of 40 in Scotland, reducing life expectancy by 20 years on average; believes that this is the highest of any cancer, but that the treatment for and understanding of brain tumours are 20 years behind those relating to more common cancers; notes that brain tumours often cause side effects that have a severe impact on quality of life; understands that 37% of patients with brain tumours in Scotland went straight to hospital for diagnosis, compared to 9% of all cancer patients in 2016, according to the Scottish Cancer Patient Experience Survey; notes the experience of Mark Richardson from Dunfermline who died suddenly of an undiagnosed brain tumour in May 2016 aged just 32; believes that there are myriad forms and over 130 different brain tumour types; further believes that some symptoms of brain tumour can mimic other equally serious conditions that often render early diagnosis and treatment more difficult in some cases; understands that brain tumour charities are working hard to fund pioneering research, raise awareness of the signs and symptoms of brain tumours, and provide support to those affected; commends the success of national campaigns, which it considers have contributed to a reduction in the average diagnosis times for childhood brain tumours from 9.1 to 6.5 weeks since 2011; believes that national campaigns are a basis on which to develop further awareness, and notes the encouragement of fundraising initiatives with the focus of delivering better outcomes for brain tumour patients.

*S5M-09430 Alex Cole-Hamilton: BBC to Help Young People Identify So-called Fake **News—**That the Parliament welcomes the BBC's launch of a new initiative to help young people distinguish what is real news and what is so-called fake news, which it considers is the dissemination of falsehoods under the guise of legitimate news reporting; understands that this will see up to 1,000 schools across the UK offered mentoring to help pupils determine the reliability of news, and high-profile BBC journalists taking part in events with students; notes the results of the study undertaken by the University of Salford in conjunction with Newsround, which showed that, while children know about the existence of fake news, they can struggle to identify what is credible; considers the phenomenon of fake news to be corrosive, a means to obstruct genuine scrutiny and a threat to democracy; therefore expresses disappointment at the Tweet by Gordon Macdonald MSP, to respond to the broadcaster's announcement of what it considers this positive new initiative by, it understands, denouncing the flagship BBC Scotland news programme. Reporting Scotland, as fake news and urges him to withdraw this remark; believes that the decision of elected politicians to dismiss what it considers are reputable sources as fake news can have serious real-world consequences, such as recent reports in *The Guardian* of media in Libya dismissing CNN reports on modern slave auctions within the country on the basis that the source has been condemned by President Trump as "a major source" of fake news; considers that elected politicians have a responsibility to help protect an effective and responsible free press, and hopes that the BBC's initiative is a success.

Members' Bills Proposals

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.

The last lodging day for amendments at Stage 2 is four sitting days before the meeting at which those amendments will be considered (e.g. Wednesday for a meeting on Tuesday); at Stage 3 it is five days before. Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for each Stage, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
