\*S5M-03537 Ross Greer: Arrest of HDP Co-chairs—That the Parliament condemns the charges brought against the People's Democratic Party (HDP) co-chairs, Selahattin Demirtas and Figen Yuksekdag, by the Turkish state; expresses concern that these charges are part of a broader crackdown against the democratic opposition in Turkey; notes that both HDP co-chairs were due to visit Scotland before their arrest to present their peace proposals for northern Kurdistan/south eastern Turkey; condemns the arrest of HDP officials since November 2016; is relieved that
