*S5M-09065 lain Gray: 10th Anniversary of The Open University's Young Applicants in Schools Scheme—That the Parliament recognises the 10th anniversary of The Open University's Young Applicants in Schools Scheme (YASS), which enables sixth year pupils to study university subjects in the classroom; notes that YASS began as a pilot project in the Highlands in 2007 and has since reached more than 6,500 pupils from over 250 schools across Scotland; understands that almost 1,200 pupils are studying with YASS in 2017, including 38 pupils at Preston Lodge High School, Ross High School and Dunbar Grammar School in East Lothian; believes that YASS benefits pupils by giving them a chance to try degree-level study in a familiar environment, building their confidence, self-esteem and aspirations, especially where they lack university-experienced role models, thus widening access to higher education, and assists schools to provide a broader range of subjects as part of their sixth year curriculum, particularly those in remote and rural areas, and sends its best wishes to everyone involved with the scheme this year and in the future.

was nicknamed the "Butcher of Bosnia", has been sentenced to life imprisonment by the UN tribunal in The Hague; recognises that the tribunal found that Mladic "significantly contributed" to the genocide in Srebrenica in 1995, in which more than 8,000 Bosniak men and boys were murdered, and the siege of Sarajevo, in which over 10,00 people lost their lives; notes that many horrific crimes were committed by troops under Mladic's command, including sexual assault, detaining prisoners in appalling conditions, forcibly deporting Bosniak citizens en masse and destroying homes and places of worship, and hopes that the verdict provides some solace to those who were affected by Mladic's crimes.

The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
