Members' Business motions that have achieved cross party support

*S5M-08218 Alex Cole-Hamilton: Incontinence in Scotland—That the Parliament understands that incontinence has the potential to affect everyone at some point and that the condition can arise as a symptom of a range of varied medical conditions, such as obesity, traumatic childbirth and muscle weakness; believes that 20% of women between 17 and 30 will experience so-called giggle incontinence, which has the potential to lead to greater complications in later life, in particular the need for surgical interventions, including transvaginal mesh implants; understands that the only country to have calculated the costs associated with this is Australia, which estimates these to be around \$43 billion (£25 billion) per year as they go beyond the provision of sanitary wear, medication and surgery, and include the cost of dealing with the depression and anxiety that can arise; recognises what it sees as the importance of physiotherapy in alleviating the symptoms, and notes that, when provided early, this has reportedly proved effective in 80% of cases; understands that there is no formal training around basic incontinence prevention in Scotland for the midwifery, health visitor or physiotherapist workforce; acknowledges the taboo around the subject, which, it believes, suppresses an open discussion about it and often prevents people experiencing the condition from seeking help, and notes the view that the case for a national incontinence strategy is compelling, as it would be important to improving the life quality of hundreds of thousands of people in Edinburgh and across the country and would be of benefit to the public purse.

*S5M-08226 Ben Macpherson: Unfair Police Scotland and Fire Service VAT Charges—That the Parliament understands that Police Scotland and Scottish Fire and Rescue continue to be the only territorial forces in the UK unable to reclaim VAT; believes that this costs £35 million annually, and has totalled £140 million since 2013; notes what it sees as the detrimental impact that paying this VAT has on frontline services in communities in Edinburgh Northern and Leith and across Scotland; acknowledges the view that the UK Government should change its rules to allow this VAT to be reclaimed, similar to the action that it took to enable Highways England and academy

*S5M-08213 Neil Findlay: NPD Funding, is it Value for Money?—That the Parliament welcomes the work by *The Guardian* newspaper and *The Ferret* online investigative journalism site, and the news that Audit Scotland and the Accounts Commission are to investigate the Scottish Government's non-profit distribution (NPD) model of financing public infrastructure projects; understands that an error made by the Scottish Government in interpreting EU rules has resulted in £932 million of expenditure that will now have to found from its own borrowing; considers that NPD projects are very poor value for money with, for example, the new Dumfries Hospital earning investors £100 million in interest on borrowing of £218 million, with loan rates of up to 11.3% being charged by private lenders as opposed to a public works loan board rate of 1.6%; understands that, under some of these contracts, public sector staff are seeing their jobs taken out of, for example, the NHS, and transferred to the private sector with no TUPE protection, and that maintenance services at sites such as the new Royal Edinburgh Hospital will see charges levied by private contractors, which are triple the rate currently paid; believes that these projects are bad for taxpayers and bad for workers; notes the view that the Parliament, through its committees, should hold an inquiry into the NPD model of financing public services, and is concerned at reports that some sub-contractors working on the Scottish Future's Trust-supported NPD projects are experiencing major problems in getting paid the amount that they are owed, having retention money kept from them for extended periods and, where mediation regarding disputes has taken place, finding that the main contractors are still withholding payment, thereby threatening jobs.

*S5M-08211 Rona Mackay: Condemns Unpaid Trial Shifts—That the Parliament welcomes the Private Members Bill introduced by Stewart McDonald MP in the House of Commons to ban unpaid trial shifts; considers that this practice infringes workers' rights and notes calls for it to be stopped; understands that young people are the group most likely to face exploitation; notes the view that, whether permanent work is offered or not, they should be paid for their work during a trial period; commends this bill, and considers that it will make a real difference for people throughout Scotland, including in Strathkelvin and Bearsden, seeking employment.
