*S5M-11737 Joan McAlpine: Appropriate Housing for People with Learning

Disabilities—That the Parliament recognises what it sees as the importance of where a person with a learning disability lives to his or her quality of life; welcomes the reported reduction in recent years in the number of people in hospitals or other NHS settings when there is no clinical need for them to be there and the shift away since 2000 from using residential care homes toward a greater use of supported accommodation; recognises the continuing challenges of ensuring the availability of appropriate housing, the accessibility of tenancy agreements and balancing sustainable care provision with people's housing preferences, and notes the view that the Scottish Government, local authorities and relevant partners should work together to ensure that every person in the South Scotland region and across the country who has a learning disability can access the appropriate housing and support that is required to give that person the choice and control to live the life that he or she wants.

*S5M-11721 Brian Whittle: Report Highlights Lack of Mental Health Support for Cancer Patients—That the Parliament acknowledges the recent report by the Mental Health Foundation, which highlighted the significant impact on a person's mental health that a cancer diagnosis can have; understands that the report found that mental health issues can often occur at the very end of cancer treatment when patients describe the sense of having "fallen off a cliff edge" as the sudden loss of support leaves them feeling isolated and abandoned; understands that of those interviewed for the report, 49% said that they received no support or advice from health services about managing their mental health through cancer, while 66% said that they were given no information about the potential for mental health problems arising at the end of their treatment; notes the calls in the report for tailored, person-centred mental health support at all stages of the cancer journey, greater collaboration among service providers, improved signposting for mental wellbeing services, clear support pathways post-treatment and further research into the most effective ways to tackle social deprivation and co-morbid health inequalities; recognises the important role that good mental health can play in the recovery process of patients, including patients in the South Scotland region, and commends the Mental Health Foundation for its work on this report.
