all school leavers; notes that the university's project seeks to reduce this gap by providing a range of outreach activities from the pre-application stage and throughout students' university experience; further notes that support is provided for mature students with a care background and that care-experienced students are recruited as student ambassadors; understands that the programme has occurred alongside the university having signed the Scottish care leavers covenant and its signing up as the first educational institution to become an official friend of Who Cares? Scotland, and welcomes the progress achieved by this programme, which has contributed to the university's 168% increase since 2011 in applicants declaring a care background, and a 305% increase in the number of offers to those declaring care experience, which it believes represents a stunning achievement for the University of Strathclyde and its leadership on widening access.
