*S5M-10258 Alexander Stewart: Alva Man Leading Campaign in the Awareness of Atrial Fibrillation in Scotland—That the Parliament welcomes the news that Ivan Williams from Alva is urging people to get checked for a rare heart condition after he said he was "freed" from the condition following his diagnosis; understands that Ivan participated in a groundbreaking inquiry by the Parliament's cross-party group on heart disease and stroke into atrial fibrillation (AF), which eventually led to the release of crucial research by the British Heart Foundation in January 2018; believes that the report considers that people in Scotland with AF who are currently undiagnosed must be identified and that there should be clear and consistent clinical pathways to optimise their treatment and management; notes that it also made 10 recommendations to the Scottish Government; believes that Ivan, who is 70, was diagnosed in 2014, but that he had lived much longer without knowing that he had the condition; understands that Ivan has expressed relief at being diagnosed so that he can get on with his life without worrying about what may be wrong; thanks him for raising the profile of the condition through his own experience and highlighting the risks if symptoms of the condition go undiagnosed and untreated; believes that AF is one of the most common types of irregular heart rhythm and that those with the condition are at a five-fold increased risk of having a stroke, which can have a devastating impact on individuals and families and be fatal; is concerned that over 96,000 people in Scotland have been diagnosed with AF. with around 145,000 people, 2.6% of the Scottish population, estimated to have the condition, and is concerned therefore that nearly 50,000 people are living undiagnosed and missing the opportunity to reduce their stroke risk through appropriate treatment. R

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
