*S5M-10125 Ross Greer: Ahed Tamimi—That the Parliament notes with concern the reported detention since 19 December 2017 of 16-year-old Ahed Tamimi by the Israeli forces illegally occupying Palestine; notes that Ahed is from Nabi Saleh, which a village in the West Bank; understands that the village has faced encroachment by Israeli settlements, resulting, it believes, in land confiscations and access to water being restricted, all of which are illegal under international law; understands that Ahed and her family, along with many others from Nabi Saleh, have faced sustained persecution and intimidation by Israeli forces due to their efforts in resisting occupation; believes that her arrest followed the shooting of her 14-year-old cousin in the head at a protest against the relocation of the United States' embassy in Israel on 14 December and the reported subsequent harassment of the family at their home by Israeli forces; expresses its grave concern at what it sees as the use of military detention against children and young people by Israel and the findings by UNICEF, which suggest that ill-treatment of young people by the Israeli military detention system is "widespread, systematic, and institutionalised", and supports the calls by Amnesty International, and other human rights bodies, for Ahed's immediate release.

*S5M-10124 Richard Lochhead: Speyside High School Wins Listening Challenge and Gains Listen Well Awards—That the Parliament congratulates Speyside High School in Moray on winning the Listening Challenge and gaining Listen Well Awards; understands that the Listening Challenge is the final component for participating young people to gain their Listen Well Award; notes that the pupils were challenged to work in teams to create promotional material to raise awareness of the benefits of listening for health and wellbeing among young people; understands that Maureen Wilson, Executive Coordinator of Listen Well Scotland, delivered two days of training to the pupils before setting the challenge; acknowledges that Speyside High School created what it considers is a powerful promotional video, designed T-shirts and initiated a breakfast for the awards, and won the challenge by unanimous decision; recognises the importance of listening well to the health and wellbeing of people of all ages and considers this vital training for young people; commends the pupils of Speyside High School and their Principal Teacher of Guidance, Amy MacInnes, who assisted the pupils on their project, and wishes all involved further success in promoting this vital aspect of health and wellbeing.

*S5M-10122 Neil Findlay: St John's Hospital Children's Ward Closed to Out of Hours Inpatients for 30 Weeks—That the Parliament understands that, as of 25 January 2018, St John's Hospital's children's ward has been closed to inpatients out-of-hours for 30 weeks and shows no sign of reopening; believes that this is failing children and their parents, who need a fully-functioning 24/7 paediatric service at the hospital, and calls on NHS Lothian and the Scottish Government to end this situation as a matter of urgency.

*S5M-10121 Kenneth Gibson: Caledonian MacBrayne to Reduce Plastic Waste on Ferries—That the Parliament welcomes the announcement by the ferry operator, Caledonian MacBrayne (CalMac), that its plans to reduce its plastic waste are at an advanced stage; notes that this announcement coincides with a national campaign to put an end to the use of single-use plastics such as straws, disposable cups and cutlery in Scotland's hospitality and retail industries; understands that, while single-use plastics are used for just a short time by passengers on ferry crossings, they can take up to 500 years to decompose and many end up in the sea and on beaches, where they can harm birds and marine life, as well as blighting Scotland's landscapes; encourages CalMac to follow the example set by other ferry operators by replacing plastic straws with paper ones on all its sailings, eliminating the use of plastic bags in its on-board shopping facilities, and opting for biodegradable or reusable cutlery and cups, and commends campaigners on their efforts to persuade the public and private sectors to eliminate plastic pollution.

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
