# Members' Business motions that have not achieved cross party support

\*S5M-12598 David Torrance: The You're Asking For It Campaign—That the Parliament welcomes the campaign, You're Asking For It, which aims to reduce the number of proxy purchases of alcohol, in which adults buy such products to pass on to someone whom they know is underage; believes that tackling this issue could help reduce both crime and antisocial behaviour, make communities safer and protect children from the harm associated with alcohol; notes that it also aims to make under 18s aware that for them to buy or attempt to buy alcohol is an offence; acknowledges that it was developed by the Scottish Alcohol Industry Partnership, the Scottish Government, Police Scotland and representatives from North Lanarkshire Council; recognises what it understands were the successful pilot schemes, which ran in Motherwell and Wishaw in 2015 and in Leith in 2016; believes that the campaign has now been rolled out across Scotland and has been welcomed in Kirkcaldy and other communities, and looks forward to what it hopes will be its success.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.

Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for each Stage, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
