\*S5M-12778 Pauline McNeill: Crisis Report, Everybody In: How To End Homelessness In Great Britain—That the Parliament commends the charity, Crisis, for its recent report, Everybody In: How To End Homelessness In Great Britain, which sets out a detailed plan to make homelessness "a thing of the past"; notes that the findings include advocating that 100,500 social homes be built annually for the next 15 years to meet the needs of the homeless and those on low incomes, a national roll-out of Housing First, which aims to provide more than 18,000 homeless people with homes and a package of specialised support, better rights for private renters and a reform to housing benefit, to legally require hospitals, prisons, the care system and other parts of the state to help find homes for those leaving their care and, finally, for Job Centres to have homelessness specialists, and agrees with the Chief Executive of Crisis that "We must not become a society that simply accepts homelessness as 'a sad fact of life'. It doesn't have to be this way".

\*S5M-12771 Annie Wells: City of Glasgow College Success at the Craftex Exhibition—That the Parliament congratulates the staff and students from City of Glasgow College who took part in the recent Craftex Exhibition; applauds their performance in winning 32 of 58 categories and 34 individual prizes; acknowledges the excellent work of the student, Stephen Graham, who won the illustrious Quilter Cheviot QC Award for Excellence in Innovation; commends Julia Kasprowska on being presented with the New Digital Media award, after being the first person to exhibit a website at Craftex; acknowledges that Julia is also the first student from the college's Business Department to take part in the event, and praises Malgorzata Rog and Tarran Ashwel, who also won prizes; welcomes the continued support that the college provides to its creative students and appreciates the extent to which it helps them achieve so highly; understands that Craftex is recognised by UK Skills as an outstanding national event for skills that has a proven track record in helping creative students embark on successful careers, and wishes the college's staff and students the very best with their endeavours.

\*S5M-12769 Alex Rowley: Strategic State Support for the Oil and Gas Industry—That the Parliament welcomes the call from Unite the Union for strategic state support in the oil and gas industry; believes that it is not in the interests of workers of offshore oil and gas companies to use the recent downturn in the industry to impose what it considers regressive working practices across the North Sea; condemns the industry for, it believes, imposing cuts to pay and holiday entitlement while increasing shift rotas following a sharp drop in the price of oil; recognises that the price of a barrel of oil fell from between \$110 and \$120 during the period 2011 to 2014 to around \$25 a barrel in early 2016; understands that more than 160,000 direct and indirect offshore jobs were lost between 2014 (463,900 jobs) and 2017 (302,200 jobs) as a result of the downturn; further understands that Oil and Gas UK estimates that the sector saw revenues fall by more than £10 billion from 2014 to 2016; believes that the price of oil recently reached \$80 a barrel for the first time in four years and that it is projected by global analysts that over the coming months the price could reach \$100 a barrel; believes that strategic support from the UK and Scottish governments could ensure maximum economic recovery while at the same time ensuring that the workforce does not pay the brunt of economic downturns through a dismantling of working benefits and conditions, and welcomes the union's repeated calls for a national decommissioning strategy with the understanding that activity in Scotland over the next 10 years could be valued at between £8.3 billion and £11.3 billion, which it considers would support peak employment of between 16,925 and 22,775 jobs.

The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
