\*S5M-12809 Rhoda Grant: SPPA Rate Charges—That the Parliament condemns what it sees as the excessive flat rate charges that are being levied by the Scottish Public Pensions Agency (SPPA) for pension data requests that are necessary in the matter of divorce proceedings; considers that these can be disproportionate to the request, particularly as they are set at a flat rate no matter the pension value; understands that, for some older people, they can represent a large proportion of their annual income, while for others, it represents a much smaller percentage; believes that these charges are unaffordable for many vulnerable people going through a divorce, including in cases of a break up of relationship due to domestic abuse; considers that this disproportionately impacts on women, who are more likely to have been in low paid or part-time work, and agrees that the SPPA should develop a system of exemptions for the charges in certain circumstances, such as financial hardship.

Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
