Kripke in 2012, which was published in the *British Medical Journal*, which found that individuals who use prescription sleeping medications are significantly more likely to die and develop cancer than those who do not; notes that this study, which examined 10,000 patients using either zolpidem or temazepam over a two-and-a-half-year period, found that those taking sleeping pills were 4.6 times more likely to die over that period than those who did not using sleeping pills in a double-blind controlled trial; further notes that, while the risk of death scaled with the frequency of use, even those who only consumed 0.5 to 18 sleeping pills per year were still 3.6 times more likely to die than those who took none at all; considers that cognitive behaviour therapy (CBT) is proven to be a more effective first-line treatment for insomnia than sleeping pills as it equips patients with techniques to break bad sleep habits, address anxieties and improve sleep hygiene; understands that, while the data on the number of sleeping medications prescribed and the number of patients diagnosed with sleep disorders is not stored centrally by the Scottish Government, in 2016-17 97,448 items of zolpidem were dispensed at a total cost of £170,866.68, 135,563 items of temazepam were dispensed at a total cost of £695,297.67 and 6,759 items of modafinil were dispensed at a total cost of £243,997.39, and therefore encourages the Scottish Government to assess the prevalence of prescription sleeping medication dispensed in Scotland, the impact on health and encourages a move towards a CBT-based model for the treatment of sleep disorders to mitigate the potential risk to public health posed by prescription sleep pills.

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
