*S5M-13020 Alexander Stewart: Precision Medicine—That the Parliament welcomes the rapid development of precision medicine, which is a medical model that proposes the customisation of healthcare, with medical decisions, treatments, practices or products being genetically tailored to the individual patient; acknowledges that, with this model, diagnostic testing is often employed for selecting appropriate and optimal therapies based on the context of a patient's genetic content or other molecular or cellular analysis; notes that tools employed in precision medicine can include molecular diagnostics, imaging and analytics; further notes that this does not mean that the creation of drugs or medical devices are unique to a patient but rather the ability to classify individuals into subpopulations, which differ in their susceptibility to a particular disease, or in the biology or prognosis of diseases that they may develop such as cancer, or in their response to a specific treatment; acknowledges that preventive or therapeutic interventions may then be concentrated on those who will potentially benefit, thus sparing expense and side effects for those who will not; considers that, on the treatment side, precision medicine can involve the use of customised medical products such as drug mixes produced by pharmacy compounding or customised devices; is aware that this technique can prevent harmful drug interactions, increase overall efficiency when prescribing medications and reduce costs associated with healthcare; understands that artificial intelligence (AI) provides an example of the shift toward precision

medicine, with machine-learning algorithms being used for genomic sequences and for analysing and drawing inferences from the vast amounts of data that patients and healthcare institutions have recorded; is encouraged by AI techniques already being used with success in precision cardiovascular medicine to understand genotypes and phenotypes in existing diseases, and is enthused by what it considers the enormous potential of precision medicine in all disciplines to vastly improve the quality of healthcare for patients in the Mid Scotland and Fife region and across Scotland, and to enable cost-effectiveness and a reduction in patient readmission and mortality rates.

*S5M-13008 Kenneth Gibson: Celebrating the Works of Sir John James Burnet—That the Parliament recognises that 2 July 2018 marks the 90th anniversary of the death of Sir John James Burnet, renowned Scottish Edwardian architect and one of the most influential forces in the British Modern design school of the 20th century; understands that, after being educated in Glasgow and training for two years in the architectural offices of his father, John Burnet, John James Burnet attended the École des Beaux-Arts in Paris and learned from the architectural masters of Europe; notes that in 1878 Burnet won the competition to build the Fine Art Institute in Glasgow, his first truly independent work, which marked his progression to other major works, including the Edward VII Galleries at the British Museum in London, the Athenaeum and Alhambra theatres in Glasgow, RW Forsyth's department store in Edinburgh and Unilever House in London; believes that the style of architecture developed by Burnet, termed "Burnet Baroque", was influential in the work of other notable Scottish architects such as Thomas Smith Tait, who went on to become a partner in Burnet's firm and is celebrated today as the designer of St. Andrew's House in Edinburgh and the pylons for the Sydney Harbour Bridge, and hopes that Sir John James Burnet is celebrated for years to come as part of Scotland's world-renowned architectural legacy.
