S5M-10949 Miles Briggs: Improving Edinburgh's City Bypass—That the Parliament considers that good transport links, including trunk roads such as the A720 Edinburgh city bypass, are key to future economic development; understands that studies have shown that parts of the bypass are now among the most congested in the whole of the UK, with significant costs to the area's economy; is aware of reported concerns of residents, commuters, businesses and business organisations, such as the Federation of Small Businesses, in Lothian regarding the frequent, lengthy tailbacks and delays experienced on the route, especially at peak times; understands that it will be 2019 until the draft orders for the long-awaited plans to introduce grade separation at the Sheriffhall Roundabout are published; further understands that the Scottish Government expects an extra 10,000 vehicles per day will be using the bypass by 2022, compared with the 2014 figure, with an extra 20,000 vehicles per day predicted by 2032, and, in light of this, notes the calls for the Scottish Government to prioritise further improvements to the city bypass and assess how it can expand capacity and develop innovative, long-term solutions that will keep traffic moving on what it considers is a key national trunk road.

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
