\*S5M-12076 Keith Brown: Scottish National Investment Bank—That the Parliament notes the publication of the Scottish National Investment Bank Implementation Plan, which sets out proposals and recommendations for the establishment of the bank, and further notes the emphasis that these proposals place on the bank being bold and ambitious by providing patient mission-based finance, which will help create and shape future markets and help Scotland achieve its full economic potential.

\*S5M-12072 David Stewart: Clean Air Day 2018—That the Parliament notes that Clean Air Day takes place on 21 June 2018 and provides an opportunity to learn more about air pollution; understands that the World Health Organization has described air pollution as "a public health emergency" and "the biggest environmental risk to health, carrying responsibility for about one in every nine deaths annually at a global level"; further understands that outdoor air pollution contributes to an estimated 40,000 premature deaths in the UK each year and that, on a global level, cardiovascular disease accounts for an estimated 80% of deaths related to outdoor air pollution; considers that, in Scotland, public exposure to air pollution is most likely to come from traffic sources, and that traffic pollution can contribute to the development of cardiovascular disease; notes the calls on the Scottish Government to continue to develop a strong infrastructure for both active travel and low-emission vehicles to support a move away from high-polluting vehicles, and further notes the calls on people throughout Scotland to consider how they can reduce the country's air pollution on Clean Air Day 2018.

\*S5M-12079 David Torrance: Success at Advanced Healthcare Awards—That the Parliament congratulates NHS Fife biomedical scientists on winning an award at the 12th annual Advanced Healthcare Awards (AHA), which were held at the Chelsea Harbour Hotel in London on 20 April 2018; notes that Dr Mairiead MacLennan, Lisa Logan and Stephen McGlashan are all biomedical scientists on the microbiology team at the Victoria Hospital in Kirkcaldy, and are members of the Institute of Biomedical Science; further notes that the team won the Scottish Government's AHA award for Driving Improvement, Delivering Results; understands that the team was nominated after setting up a rapid flu testing system that would allow nurses to confirm whether or not a patient has flu in as little as 30 minutes, as opposed to the 24 hours it would previously have taken; commends the team for all its hard work, and wishes it continued success in the future.

\*S5M-12078 Clare Haughey: Mental Health Awareness Week 2018—That the Parliament welcomes 2018's Mental Health Awareness Week, which runs from 14 to 20 May; understands that the Mental Health Foundation's chosen theme for this year's campaign is Stress - Are We Coping?; highlights that tackling stress can go a long way to address mental health problems such as anxiety and depression and, in some instances, self-harm and suicide; recognises research that estimates that 13.3 million working days are lost per year due to stress, depression and anxiety; encourages people to look out for the signs of stress, which include increased blood pressure, headaches, nausea, indigestion and increased perspiration, as well as emotional and behavioural changes, such as experiencing anxiety, anger or difficulty sleeping; calls on people experiencing stress to talk about their problems with others, and to seek professional help if they feel they are no longer able to manage it themselves, and asks that parliamentarians and the public spread recognition of this year's Mental Health Awareness Week and its theme for the maximum benefit of the people of Scotland. A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
