S5M-12482 Johann Lamont: Greencity Wholefoods—That the Parliament congratulates Greencity Wholefoods on its 40th anniversary; notes the role that it has played in the promotion of fairly-traded products in Glasgow and across Scotland; understands that the worker-owned cooperative, with 52 worker members, has an annual turnover of £8 million; notes the calls for local authorities and the Scottish Government to consider how they can support worker co-operatives; acknowledges the work of the co-operative movement and Co-operative Development Scotland in promoting worker co-operatives, and wishes Greencity Wholefoods continued success. *S5M-12481 Ross Greer: Access to Abortion in Ireland—That the Parliament welcomes the result of the referendum to repeal the eighth amendment of the constitution of the Republic of Ireland; notes that 66.4% of those who turned out voted to repeal the amendment that has prohibited abortion in almost all circumstances in Ireland since its ratification in 1983; applauds the estimated 30,000 Irish citizens abroad who returned home to vote on this important issue; congratulates Together for Yes for leading the campaign to repeal the eighth amendment; considers that nine women per day have been forced to travel from Ireland to Great Britain to access reproductive healthcare and that others, including Savita Halappanavar, have died as a consequence of this amendment; believes that access to safe and legal abortion services is an issue of global importance and that denying women, non-binary people and trans men in Northern Ireland access to abortion services is a breach of their human rights; calls on the UK Government to ensure that the law is reformed so that safe abortions are accessible for residents of Northern Ireland, and supports those campaigning for the decriminalisation of abortion across the UK.

*S5M-12480 Christine Grahame: The Genesis of the NHS—That the Parliament celebrates the establishing of the NHS 70 years ago; considers that it had its genesis in the Highlands and Islands Medical Service, which covered half of Scotland's land mass, a state-funded health system that was run directly from Edinburgh and set up 35 years earlier; notes that although treatment was not free, fees were set at minimal levels and people could still get treated even if they were unable to pay; believes that this service came into being as a direct result of the publication of the report of the Highlands and Islands Medical Service Committee, or "Dewar Report", in 1912, exposing inadequate medical and nursing services across large parts of crofting communities and recommending a new way of delivering state-funded medical services where doctors would be guaranteed a minimum salary, cost of travel would be reimbursed, they would be expected to visit all those requesting help, be involved in public health and school work, attend midwifery cases and provide themselves with adequate transport, and applauds everyone working in Scotland's health services from those early years, now and into the future.

Work Scheme for people who live with arthritis and related musculoskeletal conditions, such as back pain; recognises that the scheme was created in 1994 as a specialist disability service giving practical advice and support to disabled people who are working, self-employed or looking for work; welcomes the news that around 36,470 people were helped by the scheme in 2015-16 across the UK; notes that, in Scotland, it is estimated that almost 1.5 million people live with a musculoskeletal condition; understands that these conditions, such as arthritis and back pain, are a leading cause of sickness absence, including among the NHS workforce, which has an impact on the individual, the health service and the wider economy, if those individuals are not supported, and approves of the work by Arthritis Research UK and Arthritis Care Scotland that seeks to raise awareness of the Access to Work Scheme to help all those in Scotland and the UK who could benefit from it. **R**

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
