S5M-15657 Rachael Hamilton: Long-term Decline in Salmon Stocks—That the Parliament notes the reported long-term decline in salmon stocks across Scotland's major rivers, including the Tweed, the Spey, the Dee and the Tay; understands that catches have decreased over the last decade; notes that, on the Tweed, rod catches have fallen from 23,219 in 2012 to 6,577 in 2017; believes that this is marginally above the previous worst years, 1977 and 1980; understands that angling in Scotland supports around 2,800 jobs and contributes £100 million to the economy; acknowledges that fishing generates significant employment opportunities in rural areas; recognises that there are significant challenges ahead if salmon stocks are to return to previous levels, and notes the calls for the Scottish Government to take urgent action to devise effective conservation and management plans in conjunction with relevant bodies to help address what it sees as the persistent decline in salmon stocks.

*S5M-16765 Michelle Ballantyne: Assisted Dying Laws—That the Parliament considers that there is strong public support within the South Scotland region and across Scotland for the reform of current laws regarding assisted dying; understands that, according to a 2015 Populus Poll, 83% of the public in Scotland support assisted dying and would like to see the current laws changed; acknowledges that, while there is no specific law against assisted dying in Scotland, those who financially or logistically aid a loved one who chooses an assisted death may be prosecuted for culpable homicide; notes that there is an active cross-party group in the Parliament dedicated to the matter, and considers that campaigns to change assisted dying laws have support from MSPs from all parties; understands that an increasing number of medical bodies, most recently the Royal College of Physicians, have removed their opposition to assisted dying, and that recent legal changes in a number of countries, including Canada, the United States and Australia, mean that over 100 million people around the world now have access to assisted dying; notes the view that there is a strong desire to start a conversation in the Parliament on assisted dying; recognises the long-term suffering and loss of freedom that many degenerative and terminal illnesses cause, and notes the view that assisted dying is a serious matter worthy of proper recognition and discussion.

*S5M-16775 Kenneth Gibson: Criminalisation of Homosexuality Persists Around the World—That the Parliament regrets that a number of countries around the world still criminalise same-sex relationships, including at least eight countries in which homosexuality can result in a death penalty and dozens more in which homosexual acts can result in a prison sentence; is concerned by the implementation of a revised penal code in Brunei, which stipulates that the death penalty for offences such as rape, adultery, sodomy, extramarital sexual relations for Muslims, robbery and insult or defamation of the Prophet Mohammad; understands that the revisions, which came into force on 3 April 2019, also introduce public flogging as a punishment for abortion, amputation as a punishment for theft, and criminalises exposing Muslim children to the beliefs and practices of any religion other than Islam; believes that these changes are a direct attack on LGBT people, minority religious groups, women's rights and humanists in Brunei, and calls on the UK Government to work in partnership with other nations and international organisations to encourage greater tolerance and the development of more inclusive societies that respect diversity and human rights.

*S5M-16774 Maurice Golden: Scottish SPCA Annual Review 2018—That the Parliament recognises and welcomes the success of the Scottish SPCA in helping animals in need and championing the welfare of animals during 2018; understands that the charity answered 202,452 calls, attended over 90,000 incidents, rescued 19,532 animals, rehomed 5,068, rehabilitated and released 5,642 back into the wild and reunited 984 lost animals with their owners; praises its education programme for young people and welcomes the news that it is to be expanded in the coming years; recognises the valuable contribution that the charity makes to tackling the illegal puppy trade through its #SayNoToPuppyDealers campaign; notes the collaborative approach that the charity takes with other animal welfare organisations to inform the public and campaign for progress on animal welfare issues and recognises the important contribution made by those other organisations, and encourages the public to show continued support for the Scottish SPCA in caring for and protecting animals across Scotland.

*S5M-16773 Miles Briggs: Charity Lottery Reform—That the Parliament supports the UK Government's preferred option of a £100 million annual sales limit for charity lotteries; considers that this new limit will allow such lotteries to reduce bureaucracy and administration costs and therefore return more to good causes; understands that such a limit was recommended by the Gambling Commission and has the support of many charities and voluntary sector organisations, including in Lothian; believes that setting the limit at £100 million will future-proof it for the decade ahead; hopes that the UK Government will be able to implement the new limit as soon as possible, and believes that this will benefit charities and voluntary sector organisations across the country.

*S5M-16772 John Mason: Assisted Dying Law—That the Parliament considers that the public is split in its views concerning the current laws regarding assisted dying; understands that, while some people support assisted dying and would like to see the current law changed, others are concerned that it would be impossible to put adequate safeguards in place, and considers that the abuse of vulnerable people would probably take place; acknowledges that the Parliament has twice decided that the law should remain as it is; believes that opposition to changing assisted dying laws has support from a wide cross-section of society outwith Parliament and from MSPs of various parties; considers that, while recent legal changes in a number of countries, including Canada, the United States and Australia, mean that over 100 million people around the world now have access to assisted dying, Scotland should not just follow what it sees as the current fashion, but should decide on the merits of the case; acknowledges the view that, while there is a strong desire from some to continue the conversation in Parliament on assisted dying, considers that there must be a question as to how frequently it returns to the same issue; understands that, historically, there have been some families that wished the early demise of an elderly relative for financial gain and that there could be strong budgetary pressures on the state and others to save on care costs by encouraging the assisted dying of vulnerable individuals; recognises the excellent palliative care provided by nursing homes, hospices and others to help those suffering from degenerative and terminal illnesses, and notes the view that dying is a serious matter worthy of proper recognition and discussion.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
