***[S5M-17581](#) Rhoda Grant: Police, Fire and Ambulance Service Volunteers**—That the Parliament applauds everyone who volunteers with the police, fire and ambulance services in the Highlands and Islands and across Scotland; recognises the value of all of their efforts to support these vital services; acknowledges that, on many occasions, they are the unsung heroes, and notes what it sees as the disparity regarding the payment and free equipment that is provided by each service.

***[S5M-17598](#) Alex Cole-Hamilton: Heads Up @ Clermiston**—That the Parliament acknowledges the work done by Heads Up @ Clermiston, located on St John's Road in the Edinburgh Western constituency, over the last five years; recognises its work in bringing people in the community together; notes its dedication to social inclusion and peer support; recognises the link between social exclusion, long-term conditions and mental health issues, and applauds Heads Up @ Clermiston for its commitment to supporting people with long-term conditions.

***[S5M-17597](#) Bill Kidd: Link Between Civil and Military Nuclear Use**—That the Parliament notes analysis by the University of Sussex, which suggests that energy bills are inflated to partly subsidise the UK's nuclear weapons arsenal; highlights that the university's Science Policy Research Unit has published evidence brought to light by Professor Andy Stirling and Dr Phil Johnstone identifying "that the need to maintain submarine nuclear capabilities in the military sector has played an influential role in the UK's decisions to champion nuclear power" and the finding that suggests that this provides "a compelling explanation for the UK's resolute commitment to nuclear energy projects... despite the widespread criticism of its economic and technical feasibility"; believes that the UK Government spends £2.2 billion per year on nuclear weapons and that a single nuclear weapons system could cost from £74 billion to £140.5 billion over its lifetime; recognises calls on the UK to adopt the 2017 UN Treaty on the Prohibition

***[S5M-17596](#) Annabelle Ewing: Congratulations to Edible And Tasty Spaces Rosyth**—That the Parliament notes the success of Edible And Tasty Spaces (EATS) Rosyth at the Fife Voluntary Action Awards, where it won the Reducing Inequalities Award; acknowledges the excellent work done by EATS Rosyth in its community garden and orchard projects and in encouraging people to learn how to garden and grow their own food; notes the success in holding regular community meals and showing how locally grown fruit and veg can be used in cooking; believes that it is doing valuable work in the local community, and wishes EATS Rosyth continued success in the future.

***[S5M-17595](#) Adam Tomkins: Another Successful Year for the Scottish Event Campus, Glasgow**—That the Parliament congratulates the Scottish Event Campus (SEC) in Glasgow for another hugely successful year, in which trading turnover increased by 21% to £35.1 million; understands that, aside from the year of the Commonwealth Games in 2014, the most recent financial year has been the most successful 12 months ever for the SEC; notes that every sector in which it operates delivered a record performance, with 55% growth in turnover for conferences, growth of 3% for the exhibition sector and a 24% increase in turnover for the live entertainment sector; welcomes that the SEC attracted almost 2.1 million people in 2018, with 1.1 million attending shows and events at the SSE Hydro; acknowledges the wider economic impact of the SEC, which generated net additional expenditure of over £1.35 million per day in the Glasgow area, amounting to a total of £457 million for the year; congratulates its executive team and all staff for building what it believes is one of the world's top venues, and believes that the further plans for expansion could help the campus go from strength to strength.

***S5M-17589 Kenneth Gibson: 75th Anniversary of the D-Day Landings**—That the Parliament commemorates the 75th anniversary of the D-Day landings, which took place on 6 June 1944 and marked the start of the Allied forces' campaign to liberate Northern Europe from Nazi occupation; notes that there are a number of commemorative events taking place in both Scotland and France to remember the contribution that Scottish soldiers made to the campaign, including a lament played in Arramanches in Normandy by a lone piper, Pipe Major Trevor Macey-Lillie of East Ayrshire; understands that Pipe Major Macey-Lillie began his lament on top of the remaining Mulberry artificial harbour in the town at 06.25, signalling the time at which the first British soldier stepped onto Gold Beach at the beginning of the D-Day landings; acknowledges that, as part of the commemorations, a number of Scottish veterans are joining a group of 300 Allied forces veterans in attending ceremonies at Bayeux Cathedral and Bayeux War Cemetery, where many of the fallen were buried; recognises the bravery shown by all those who took part in the D-Day landings, including the Scottish soldiers, sailors, air crew and engineers, who made this pivotal operation possible through their personal sacrifices; pays tribute to the estimated 4,400 allied

Members' Bills Proposals

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.

Gil Paterson: Proposed Post-Mortem Examinations (Defence Time-Limit) (Scotland) Bill — A proposal for a Bill to make the right of the defence solicitor for a person accused of homicide to instruct a post-mortem examination of the alleged victim subject to an extendable time-limit in order to minimise delays and uncertainty for victims' families. The last lodging day for amendments at Stage 2 is four sitting days before the meeting at which those amendments will be considered (e.g. Wednesday for a meeting on Tuesday); at Stage 3 it is five days before. Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for each Stage, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
