20 years of the Scottish Parliament, the UK Government should rescind the Scottish Adjacent Waters Boundaries Order 1999; considers that, under this regulation, 15,000 square kilometres of Scottish waters, as agreed in the Continental Shelf (Jurisdiction) Order 1968, were transferred unilaterally from Scottish to UK jurisdiction; understands that this was carried out on 13 April 1999, just weeks before the Scottish Parliament came into being, without being debated in the House of Commons; further understands that what it considers this annexation of Scottish waters and seabed gives the UK Government control over oil, gas and other minerals in that sector, which includes the Auk, Catcher, Clyde, Curlew, Fulmar, Janice, Judy, Leven, Medwin and Orion oilfields, and regrets what it sees as the acquiescence of unionist parties north of the border in meekly accepting this state of affairs.

 - (d) conduct research into—
 - (i) the types of transitional support which may be necessary in the sectors and regions most affected in meeting the Act’s targets,
 - (ii) the outcomes of measures and support put in place to achieve a just transition,

- (3) The Commission's members and employees are not to be regarded as civil servants.
- (4) The Commission's property is not to be regarded as property of, or held on behalf of, the Crown.

Independence

- 2 In performing its functions, the Commission is not subject to the direction or control of any member of the Scottish Government.

Membership

- 3 (1) The Commission is to consist of—
- (a) a member to chair the Commission, and
 - (b) at least 8 members.
- (2) The Scottish Ministers are to appoint the members, one of whom must be a nominee of the trade union movement and one of whom must be a representative with experience and knowledge of ecological and environmental matters.

- (e) is or has been disqualified under any disqualification provision analogous to either of those mentioned in paragraphs (c) and (d), anywhere in the world.

 - (b) the person has granted a trust deed for creditors or has made a composition or arrangement with creditors,

Members' Bills Proposals

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
