*S5M-17483 Richard Leonard: Contribution of David Martin in 35 Years as an MEP—That the Parliament recognises the contribution of David Martin, the longest serving UK Member of the European Parliament (MEP), who was first elected to serve the interests of Scotland in 1984; acknowledges that David first served as MEP for the Lothians from 1984 to 1999 before representing all of Scotland until 2019; regrets the fact that, with David not being returned at the recent European parliamentary elections, Scotland will no longer be represented within the Progressive Alliance of Socialists and Democrats group in the European Parliament; considers that David helped advance the cause of workers' rights and fair trade in the EU, and that, during his tenure as Vice President of the European Parliament, was instrumental in developing the Maastricht Treaty; congratulates David on all his successes throughout his time in the European Parliament, and wishes him well in his future endeavours.

*S5M-17482 Alison Johnstone: Promoting Podiatry as a Career Choice—That the Parliament recognises the important role that podiatry plays in the prevention and early intervention of medical conditions; understands that podiatry treatment can reduce demand on secondary care services and improve patient outcomes; further understands that the most recent statistics show a vacancy rate of 5.4% in podiatry services, compared with 1.2% in 2013, and that the number of whole time equivalent podiatrists working in Scotland reduced by 1.3% between December 2017 and December 2018; considers that, given that more people are living with complex conditions that can lead to foot and lower problems, such as diabetes, rheumatoid arthritis and peripheral arterial disease, the reduction in the number of podiatrists working in Scotland's NHS is a major public health concern; notes that the Office for Students is funding the strategic interventions in health education disciplines (SIHED) programme, which aims to increase awareness of allied health disciplines, and calls on the Scotlish Government to launch a similar initiative in Scotland as a means of promoting podiatry as a career.

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
