**\*S5M-22218 Stuart McMillan: Action Mesothelioma Day 2020**—That the Parliament recognises that Action Mesothelioma Day 2020 takes place on 3 July 2020; understands that mesothelioma is a deadly cancer caused by breathing in asbestos dust; notes that asbestos is a naturally occurring fibre that was widely used in construction and other industries until it was banned across the UK in 1999; recognises that mesothelioma takes a long time to develop, with many people getting the first symptoms 30 to 40 years after they were first exposed to asbestos; notes that carpenters, joiners, plumbers, heating and ventilation engineers, electricians, electrical fitters, pipe fitters, metal plate workers, shipwrights, riveters, labourers in other construction trades, sheet metal

workers, construction operatives, energy plant operatives, painters and decorators, building inspectors, vehicle body builders and repairers, metalworking production and maintenance fitters, shipbuilding workers, railway engineering workers, people who have worked on DIY projects, particularly artexing ceilings or working with guttering or insulation materials, are at a higher risk of developing the condition; recognises that people who lived with someone who worked with asbestos could also develop mesothelioma, and congratulates the work of charities, such as Asthma UK and the British Lung Foundation Partnership, which have spent over £9.3 million on mesothelioma research and offer information and support to those affected.

**\*S5M-22207 Monica Lennon: Gift Aid Emergency Relief Package**—That the Parliament supports the call from a coalition of charities from across the UK to introduce Gift Aid Emergency Relief to support third sector organisations in light of the COVID-19 pandemic; notes with concern that charity and voluntary organisations are currently experiencing a severe strain on operations and resources, with evidence from the Charities Aid Foundation suggesting that 35% have experienced an upsurge in demand for services, while 53% have noted a decline in donations; understands that the proposed change, which is backed by the SCVO, would see the Gift Aid claimed on eligible donations increase by a third, up from the current one quarter; notes that this would mean that a £100 donation would increase to £133.33 for the charity once Gift Aid had been claimed; believes that this change could help charities across the UK to access an additional £450 million at a time when they are sorely needed; considers that this would help ensure that this extra revenue is accessible to charities of all sizes; acknowledges that charities and voluntary organisations have provided invaluable support, advice and care for people and communities across Scotland during the pandemic and must now be given practical, political and financial support to help them to continue doing their crucial work as the country seeks to recover and rebuild in the months and years ahead, and joins in supporting these calls to provide emergency relief for the third sector in what are difficult financial times.

## Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.

For each Bill, the date of the next (or most recent) event in the Bill's passage is given. Other relevant information, e.g. about lodging amendments, is given in italics.

As soon as a Public Bill (i.e. a Government, Committee or Member's Bill) has completed Stage 1, amendments for consideration at Stage 2 may be lodged; and as soon as Stage 2 is completed, amendments for Stage 3 consideration may be lodged. The last lodging day for amendments at Stage 2 is four sitting days before the meeting at which those amendments will be considered (e.g. Wednesday for a meeting on Tuesday); at Stage 3 it is five days before. Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for each Stage, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
