### Members' Business motions that have not achieved cross party support

**\*[S6M-02635](#) Fulton MacGregor: Scottish National Blood Transfusion Service** —That the Parliament recognises the work of the Scottish National Blood Transfusion Service (SNBTS); understands that the SNBTS, which had its beginnings in the 1930s, is the specialist provider of safe high quality blood, tissues and cells products and services in Scotland; notes that its cornerstone policy is to ensure that NHS Scotland has enough blood to meet the transfusion needs of patients in Scotland; praises the SNBTS for what it considers diligent work during the COVID-19 pandemic in continuing to provide a lifesaving service, despite the hardships brought on by the pandemic; notes with concern reports that Scotland has fewer registered blood donors than at any other point this century, with the number of people donating blood supplies having dropped by 13,000 over the past year; believes that estimates suggest SNBTS would need to welcome 3,300 donors per week to ensure that blood supplies remain at safe levels; supports the SNBTS Amazing Stories campaign, which highlighted personal stories of those who have received lifesaving blood donations, and notes, therefore, the calls encouraging people across the country, including in Coatbridge and Chryston, to sign up to become blood donors if they are able.

**\*S6M-02665 Pauline McNeill: Abandon Plan to Increase the State Pension Age —**That the Parliament notes research carried out by pension consultants LLP, which, it believes, has cast doubt on the UK Government's timetable for extending the state pension age; understands that the research shows that the life expectancy figures, which current increases are based on, are no longer accurate and that the century-long trend of increasing life expectancy has stagnated and is now in decline, in comparison to the estimates made in 2014; further understands that the research points to fears that the long-term impact of the COVID-19 pandemic would put further pressure on life expectancy rates; believes that the new life expectancy data fatally undermines the case for extending the state pension age; considers that it would be an appalling injustice to force people to work until their late 60s, when the evidence suggests no equivalent rise in life expectancy; believes that, for many people working in physically-demanding jobs, or experiencing age-related illness, such an extension of their working life is impossible, and urges the UK Government to take this new information into account, to prioritise treating elderly people with dignity and respect, and to abandon its plans to increase the state pension age.

**\*S6M-02662 Meghan Gallacher: Lanarkshire War Hero Dies Aged 97**—That the Parliament recognises the passing of Ian Forsyth MBE, who it considers to be a Lanarkshire war hero; understands that Ian joined the Army in 1942, as part of the first reconnaissance regiment at Lockerbie, then moved on to the 15th-19th Hussars Reconnaissance for the 11th Armoured Division in April 1942; understands that Ian was one of the first British soldiers to arrive at the Bergen-Belsen concentration camp in 1945; congratulates Ian on being named Senior Hero at the Daily Record's Our Heroes Awards in 2011, for his efforts in raising more than £1 million for other veterans; notes that, after the Second World War, he taught in various schools, including Larkhall Academy, and further notes that his work in the Polish community was recognised first by the awarding of the Cavalier's Cross, and then the prestigious Officer's Cross of the Order of Merit of the Republic of Poland.
