Members' Business motions that have not achieved cross party support

***S6M-00251 Douglas Ross: The Campaign to Restore the Consultant-led Maternity Unit at Dr Gray's, Elgin**—That the Parliament understands with concern that, following a decision in July 2018 to downgrade the consultant-led maternity unit at Dr Gray's in Elgin, many local expectant mums have to travel out of Moray to give birth; praises the efforts of midwives and all the staff who provide an outstanding service for those who can give birth there, but believes that too many women are made to travel outwith Moray to give birth; understands that the Scottish Government has commissioned an independent review of maternity services at Dr Gray's to consider how best to restore the consultant-led service; commends the Keep MUM group and the local campaigners who are fighting hard to have the service restored; understands that the community was originally told that the downgrade would be temporary for up to a year, but notes that, almost three years on, the service has still not been restored, and notes the calls on the Scottish Government and NHS Grampian to urgently seek a resolution to this issue and to provide families in Moray with the locally-based maternity services that they deserve.

***S6M-00256 Collette Stevenson: South Lanarkshire Colleges United Against Gender-based Violence**—That the Parliament congratulates South Lanarkshire College as it takes part in a new pilot to help tackle gender-based violence; notes that the college is only one of two colleges in Scotland to take part in the charter, which was created by EmilyTest, a Scottish charity working to improve prevention, intervention and support concerning gender-based violence in further and higher education; recognises that South Lanarkshire College has been incredibly proactive in undertaking work in this area to facilitate a safe environment for all staff and students and welcomes that its efforts have extended into the wider community through participation in local events and activities, and considers that, through such efforts, everyone can share the hope that, one day, the charter will be rolled out across all colleges and universities.

***[S6M-00255](#) Mark Griffin: Carers Week 2021**—That the Parliament welcomes Carers Week 2021, which is an annual campaign that, this year, takes place from 7 to 13 June on the theme of “Making Caring Visible and Valued”, and coming together to recognise the contribution of the 1.1 million unpaid carers and young carers in Scotland; acknowledges that it is organised by the five charities in Scotland, Carers Scotland, Carers Trust Scotland, MND Scotland, Oxfam Scotland and Age Scotland; understands that there will be hundreds of events held virtually across Scotland, which will reach out to thousands of unpaid carers and young carers; values the significant and vital contribution of unpaid carers and young carers during the COVID-19 pandemic, and considers that the impact of caring on the health and wellbeing of unpaid carers and young carers, including social isolation, should not be underestimated; recognises that many unpaid carers and young carers have struggled to get a break from caring and understands how important short breaks are to maintain positive health and wellbeing; understands that the support that carers provide is worth more than £43 million to the economy every single day; considers that every effort should be made to ensure that unpaid carers and young carers receive the support that they need, including support to take a break and reduce the impact of the pandemic on their lives and recognise their particular needs as lockdown eases, and wishes Carers Week every success.

***[S6M-00254](#) Stuart McMillan: Pawsitively Purrfect Named Pet Provider of the Year**—That the Parliament congratulates the Port Glasgow-based business, Pawsitively Purrfect, on being named Pet Provider of the Year for the Glasgow and West Region by Prestige Awards/Business Scotland Magazine; notes that business owner, Christina O’Donnell, saw off competition from more than 60 other companies to land the top prize; understands that a panel of judges chose Pawsitively Purrfect based on reviews, web and social media presence and community impact, as well as mystery shoppers; believes that this award is testament to the high-quality service that Christina provides to her customers, and wishes her and her business well for the future.

***[S6M-00253](#) Monica Lennon: World Environment Day 2021**—That the Parliament recognises that 5 June 2021 is World Environment Day and marks the official launch of the UN Decade on Ecosystem Restoration campaign; notes the theme this year is Reimagine, Recreate, Restore; understands the UN Decade aims to prevent, halt and reverse the degradation of ecosystems on every continent and in every ocean; believes that reviving damaged ecosystems across the world can help to combat climate change and tackle poverty if everyone, from multi-national corporations to individuals, assesses their own consumption patterns and carbon footprint; welcomes action by Scottish local authorities who have signed up to the Clyde Climate Forest Project and have committed to plant 18 million trees prior to COP26, and urges the Scottish Government to continue supporting initiatives that promote healthy ecosystems.

***[S6M-00252](#) Fiona Hyslop: West Lothian College Creates New Qualification for COVID-19 Mobile Testing Unit Operatives**—That the Parliament welcomes the partnership between West Lothian College and the Scottish Ambulance Service to develop a new vocational qualification in health and social care for staff working at Mobile Testing Units (MTUs) across Scotland where they provide easy access to a COVID-19 test; understands that the nine-week Gateway to Health and Social Care course provides MTU operatives the opportunity to formally demonstrate the skills and knowledge that they have developed in their work at the testing centres; notes that this provides staff with a transferable qualification for further opportunities in health and social care once the testing centres are no longer required, and commends the college for its responsiveness in supporting employers such as the Scottish Ambulance Service to help their employees gain the skills to adapt to changing circumstances.
