Members' Business motions that have not achieved cross party support

***[S6M-01994](#) Gillian Martin: Carbon Capture Utilisation and Storage as Part of Scotland's Net Zero Ambitions**—That the Parliament recognises what it sees as the Scottish Government's ambitious target to reach net zero greenhouse gas emissions by 2045, its interim target of 75% reduction by 2030 and its strong support for the Scottish cluster of proposed carbon capture utilisation and storage (CCUS) projects; understands that the UK Government's evaluation process scored the Acorn Project in Aberdeenshire as the most deliverable project in the UK; notes the calls on the UK Government urging it to change its decision regarding investing in CCUS in Scotland and award the Scottish cluster Track-1 status as part of a wider strategy to achieve as much carbon storage as possible; recognises what it believes would be the impact on the north east in particular of the UK Government failing to support the Scottish cluster; believes that this is a pivotal moment for CCUS on the decarbonisation pathway; notes the advice from the Climate Change Committee on the importance of CCUS toward reaching Scotland's net zero commitments, and believes that this is a view shared by many industrial partnerships.

***[S6M-01892](#) Jim Fairlie: Tackling Misogyny and Violence Against Women and Girls**—That the Parliament believes, and is concerned, that misogyny and violence against women and girls continues to blight society; welcomes the Police Scotland campaign, Don't be that Guy, as what it considers a positive contribution in encouraging men to take responsibility for stopping violence and discrimination against women and girls across all settings and, it considers, in tackling the idea that it is the responsibility of women and girls to protect themselves from male violence, rather than the other way round; considers that what it sees as male-dominated environments and organisations, such as sports clubs, have a particular role to play in spreading this message; believes that lasting change happens when small acts are repeated en masse, and notes the call for individual men, including those in the Perthshire South and Kinross-shire constituency, to make the simple changes to their behaviour that it considers can lead to the societal peer group change in attitudes that it believes is needed to bring an end to the pathways that lead to discrimination and violence against women and girls.

***S6M-01982 Edward Mountain: Scourie Community Development Company Wins a Helping it Happen Award**—That the Parliament congratulates Scourie Community Development Company on winning the Working with Communities Award, sponsored by the MacRobert Trust, at the national Helping it Happen Awards, which is organised by Scottish Land and Estates; notes the company's outstanding community work throughout the COVID-19 pandemic by ensuring that the area was supported with a food larder in the village shop, provided with access to mental health support and that funding was provided to help people whose livelihoods were impacted by the lockdown; welcomes the sports pavilion built by the company that is used by the whole community and the seasonal treats the company provides, such as the three-course Christmas lunch for 78 older people and Easter and Christmas goody boxes for all of the children in the area; commends the company's commitment to community regeneration, and applauds its aims for more sustainable projects to be developed.

***[S6M-01978](#) Sharon Dowey: UK Government to Invest £3.5 Million to Level Up**

Ayrshire—That the Parliament welcomes the UK Government's recent commitment to level up Ayrshire by providing almost £3.5 million through the Community Renewal Fund, which aims to invest in people, boost skills and support community businesses, with projects in East Ayrshire, such as a re-use hub for New Cumnock and leisure at the heart of all communities, receiving a large proportion of this; believes that this will strengthen communities by boosting employment and attracting tourism, and welcomes what it sees as the continued support from the UK Government to help people in Ayrshire.

***[S6M-01977](#) Sharon Dowey: Girls Night in Ayrshire, Looking After the Safety of**

Women—That the Parliament recognises the work of Girls Night in Ayrshire, which is a new group that has been launched to look after women's safety in the area in response to the reported recent increase of spiking incidents reported across Scotland; acknowledges that it has sent an open letter to Ayrshire's pubs and clubs in a bid to make the community safer; understands that many young women currently feel unsafe about going out in the evenings; notes that Police Scotland and universities and colleges across the country are working to address these concerns, and wishes groups such as Girls Night in Ayrshire well as they aim to eradicate spiking.

***[S6M-01976](#) Liam Kerr: Aberdeen Leads the Way with Hydrogen Buses**—That the Parliament commends Aberdeen City Council for introducing Europe's largest fleet of hydrogen-powered double-decker buses, which will save one kilogram of CO2 with each kilometre driven and take only 10 minutes to refuel; notes what it sees as Aberdeen's impressive and vital work to reach Net Zero and believes that the north east is leading the fight against climate change; considers this to be fantastic work, and hopes that it will continue.
