***S6M-01611 Stephanie Callaghan: Professor Dave MacMillan from Bellshill Awarded the 2021 Nobel Prize for Chemistry**—That the Parliament congratulates Dave MacMillan, who was born in Bellshill, on being awarded the 2021 Nobel Prize for Chemistry in recognition of him developing a tool that allows scientists to develop new molecules to make chemistry greener; applauds Dave's dedication to chemistry, including his doctoral studies at the University of California, post-doctoral studies at Harvard, his independent career at Caltech and subsequently as the James S McDonnell Distinguished University Professor at Princeton; recognises the extraordinary high regard that Dave is held across the globe, including winning many prestigious science awards and being elected as a Member of the National Academy of Sciences, Member of the American Academy of Arts and Sciences and a Fellow of the Royal Society; notes that Dave's early education was provided at Stevenston Primary School and Bellshill Academy in North Lanarkshire, before he graduated with a degree in Chemistry at the University of Glasgow, and applauds Scotland's public educational system for providing the foundations for Dave's astonishing work, particularly his teachers and lecturers who inspired a young man from Bellshill to globally make his mark on pharmaceutical research and win the pinnacle of scientific accolades, a Nobel Prize.

***S6M-01591 Meghan Gallacher: E-scooter Safety**—That the Parliament wishes to raise awareness about what it sees as the dangers that electric scooters pose to people who are visually impaired; understands that Guide Dogs UK is currently campaigning to raise awareness of the dangers that e-scooters present to people with vision impairment; understands that e-scooters are practically silent, meaning that people with sight loss have little or no warning of their approach; acknowledges that Guides Dogs UK has noted that even a near miss from irresponsible e-scooter riders will often rob visually impaired people of the confidence that they rely upon to move about society independently; understands that a survey undertaken by Guide Dogs UK in April 2021 found that over half of the respondents had seen e-scooters being used irresponsibly, and calls on the Scottish Government to consider the potential impact of e-scooter legislation on people with sight loss.

***S6M-01590 Meghan Gallacher: Nobel Prize for Bellshill Born Scientist**—That the Parliament congratulates David MacMillan on winning the 2021 Nobel Prize for Chemistry, together with Benjamin List, and acknowledges that David, who was born in Bellshill, worked with German-born Benjamin on mirror image molecules, which it understands will be an invaluable new tool for researchers.

***S6M-01579 Kaukab Stewart: Hyndland Secondary School Secures Top Marks from LGBT Youth Scotland**—That the Parliament congratulates Hyndland Secondary School on achieving the LGBT Charter Mark at Gold level; recognises the hard work and dedication of pupils and staff in achieving this prestigious award from LGBT Youth Scotland; understands that the school celebrated LGBT History Month and created a unique drama lesson plan based on the film *Love, Simon*, and welcomes the training and the review of policies, practice and resources that aim to ensure that the school goes beyond meeting legislative needs, and is as inclusive as it can be for pupils, staff, parents and the wider community.

***S6M-01573 Marie McNair: Milngavie in Bloom Receives National Recognition—**That the Parliament commends the volunteer group, Milngavie in Bloom, for its recent recognition by the environmental charity, Keep Scotland Beautiful; understands that Milngavie in Bloom has been maintaining and transforming green spaces in Milngavie town centre and surrounding areas since 2008; further understands that volunteers regularly organise community litter picks on busy roads, and planter maintenance in the precinct, ensuring Milngavie's civic spaces are pleasant and welcoming for residents and visitors; acknowledges the dedication of Milngavie in Bloom volunteers throughout recent challenges, and recognises the importance of its work in view of the climate and nature emergency.

***S6M-01557 Pam Duncan-Glancy: World Osteoporosis Day 2021—**That the Parliament acknowledges that 20 October 2021 is World Osteoporosis Day, a global initiative that helps to raise awareness of osteoporosis; understands that around 300,000 people in Scotland are currently living with osteoporosis; further understands that there are around 44,000 fragility fractures every year; notes that a fragility fracture is a red flag that can predict further fractures; highlights that this is particularly the case with vertebral fractures, which are a powerful predictor of future vertebral and hip fractures; notes the reports that estimate around 180,000 people are living with undiagnosed vertebral fractures in Scotland; understands that, without identification and treatment, a person is nearly three times more likely to have a hip fracture, and five times more likely to have another vertebral fracture; welcomes that Scotland is said to provide world-class secondary fracture prevention services, providing 100% population coverage of Fracture Liaison Services; further welcomes the publication of the Women's Health Plan, which commits to ensuring that women are properly supported around the time of the menopause to assess their future risk of osteoporosis and fractures, and offered appropriate lifestyle advice, and recognises the vital work of the Royal Osteoporosis Society in supporting people in Scotland who are living with osteoporosis.
