**\*[S6M-03817](#) Annabelle Ewing: Kelty Hearts FC, Scottish League 2 Champions**—That the Parliament congratulates Kelty Hearts FC on winning Scottish League 2 with five matches remaining in the season; understands that the club only became a full Scottish Football Association member in December 2017 and secured promotion to the national leagues following two consecutive seasons as Champions of the Lowland League; considers this to be a remarkable rate of progression through the pyramid system, and wishes the club every success next season in Scottish League 1.

**\*[S6M-03813](#) Audrey Nicoll: International Day of the Midwife, 100 Years of Progress**—That the Parliament recognises the International Day of the Midwife on 5 May, which will celebrate 100 years of progress throughout the global midwife community; understands that this has included advocating for quality midwifery care to improve newborn and maternal health; recognises the vital role of midwives in Scotland in aiming to deliver person-centred, high-quality care for mothers and babies throughout pregnancy, birth and following birth; commends the positive impact that midwives can have on the health and life chances of women and babies; recognises what it considers the commitment of midwives caring for women during the COVID-19 pandemic and the impact on maternal mental health as midwifery services were modified, thereby impacting women's choices during pregnancy and birth; acknowledges the policy, The Best Start: A Five-Year Forward Plan for Maternity and Neonatal Care in Scotland, to make care locally accessible, with midwives providing high-quality care to women across Scotland in homes, communities and midwifery-led and consultant-level services, and recognises what it sees as the pivotal role of educators, researchers and students, including those based at the Robert Gordon University in the Aberdeen South and North Kincardine constituency, in supporting the delivery of midwifery services in Scotland and beyond.

### Members' Business motions that have not achieved cross party support

**\*S6M-03812 Katy Clark: Removal of Season Passes on Largs-Cumbrae Route—**That the Parliament notes reports that a petition to reverse the decision to remove annual passes from the Largs to Cumbrae ferry route has been signed by roughly one third of people on the island; understands that 12-, six- and three-month season tickets have been phased out to simplify fares and ensure consistency following the roll-out of the Road Equivalent Tariff (RET) on the Clyde and Hebrides Ferry Services (CHFS) network; further understands that the 12-month season ticket for the route cost £463.40 in 2020, whereas buying five daily tickets a week, at current prices, would result in an annual cost of £864, an increase of 86%; notes that the Scottish Government's Scottish Ferries Plan 2013-2022 pledges that "RET single fares will be competitive with any discounts that would or might be available through any multi-journey equivalent ticket scheme"; further notes findings from the Evaluation of Road Equivalent Tariff on the Clyde and Hebridean Network, prepared for Transport Scotland in March 2020, that "not all island residents experienced a large reduction in fares compared to previous multi-journey books" and "this is particularly the case in the Firth of Clyde islands where the use of multi-journey tickets was widespread"; believes that promoting the use of season tickets more widely would have led to greater uptake among islanders; understands that the one-month season ticket will continue to be sold further into 2022 to adjust to phased withdrawals, but notes calls for a more affordable interim multi-journey equivalent ticket scheme to be put in place to prevent inflation of commuter travel costs, and further notes calls for the Scottish Government to meet with Transport Scotland and CalMac with a view to reviewing the application of RET rules along the Largs-Cumbrae route until the situation can be resolved.

**\*S6M-03811 Katy Clark: Shipbuilding—**That the Parliament notes that Turkey-based Cemre Marin Endustri has been commissioned to build two CalMac ferries for Islay, with state-owned yard Ferguson Marine at Port Glasgow not making the shortlist; notes the view that Scotland needs an industrial strategy to ensure capacity is built upon and public service vessels are commissioned and built in Scotland; understands that a significant proportion of the UK's shipbuilding capacity can be found along the River Clyde, where HMS Glasgow, HMS Belfast and HMS Cardiff are currently under construction for the Royal Navy; further understands that just two ferries operating on core service routes have been delivered to CalMac since 2007 and that half of all state-owned vessels are over 25 years old; notes that Ferguson Marine has trialled what it considers ground-breaking hydrogen-fuelled ferries through the HySeas III project and has a seat on the UK Government's Clean Maritime Council; further notes that the International Maritime Organization's Greenhouse Gas Strategy commits countries to reduce greenhouse gas emissions from shipping by at least 50% by 2050 compared to 2008 emission levels, and notes the calls for the Scottish Government to ensure that contracts to build zero emission ferries outlined in its Infrastructure Investment Plan to 2025-26 are directly awarded to publicly-owned shipyards in Scotland or the rest of the UK.

**\*S6M-03807 Katy Clark: Celebrating Freedom of Information (Scotland) Act at 20 Years—**That the Parliament welcomes the Freedom of Information (Scotland) (No. 2) Bill, drafted by the Campaign for Freedom of Information in Scotland; recognises that 28 May 2022 marks 20 years since the Freedom of Information (Scotland) Act 2002 (FoISA) received Royal Assent; is pleased

that the law has provided people and organisations, including in the West Scotland region, with a free, enforceable right to access information held by public authorities, and considers that opening up the decision-making process, knowing who and what information informs decisions, and how public money is spent are fundamental to ensuring a fair and equal society; believes, however, that FoISA has failed to keep pace with information management and changes in how publicly funded services are delivered, and notes the view in the Public Audit and Post-legislative Scrutiny Committee inquiry report on FoISA, published in May 2020, that "there is a clear need to improve the legislation, particularly in respect of the bodies that it covers and in relation to proactive publication", which also acknowledges the view that enforceable legal rights are popular with the public, and further notes the calls to ensure that access to information rights are robust and fit for purpose, and to expedite the necessary legal reform.

**\*S6M-03797 Katy Clark: Low Frequency Noise**—That the Parliament notes the concerns raised by the local community over low frequency noise (LFN) produced by generators on two drill ships, which, it understands, were berthed at Hunterston Jetty, near Fairlie, for approximately a year; further notes reports of concerns raised by the local community at Cromarty over persistent noise pollution from nearby offshore oil rigs; understands that responsibility for dealing with the majority of complaints about nuisance, such as noise, rests with local authorities and that they have a duty to investigate such complaints under the provisions of the Environmental Protection Act 1990 (EPA); further understands that frequency weighting is added to decibel measurements by Environmental Health Officers but that no recent general guidance for local authorities on LFN has been produced by either the Scottish or UK governments; notes the findings of the report, *Proposed criteria for the assessment of low frequency noise disturbance*, published by the University of Salford for the Department for Environment, Food and Rural Affairs, in 2011, which recommended "a method of assessment is needed both from the sufferer's point of view, because there is currently not much to protect them against LFN, and from the Environmental Health Officer's point of view, where guidance is needed in determining whether a nuisance exists"; further notes with concern the report's findings that surveyed complainants attributed sleep disturbance, stress, headaches, migraines and severe mental health issues to LFN; notes the calls for the Scottish Government to commission some up-to-date research into the subject to ensure best practice is followed on LFN and to protect public health, and further notes the calls for the Scottish Government to incorporate clear guidance on LFN into its National Planning Framework.

**\*S6M-03788 Katy Clark: Apprentices' Wages**—That the Parliament notes with concern the findings of the most recent Scottish Apprenticeship Pay Survey, published in 2020, which found that the median hourly wage for apprentices at levels 2 and 3 was £7.67; understands that the official guidance from Skills Development Scotland is that all employers should pay at least the real Living Wage of £9.90 an hour, as set by the Living Wage Foundation, to all workers, including apprentices; further understands that apprentices aged under 19, or in the first year of their apprenticeship, will be paid a minimum rate of £4.81 an hour from April 2022, which is nearly half the minimum rate of £9.50 an hour that is to be paid to all workers and apprentices aged 23 and over; notes the calls for the UK Government's minimum apprentice rate to be abolished and all apprentices to be paid at least the same real Living Wage rate of £9.90 an hour regardless of age; further notes the view that all apprentices in the public sector in Scotland, including in the West Scotland region, should be paid the real Living Wage rate, and notes the calls for the Scottish Government to make paying the real Living Wage to all workers and apprentices a binding condition for employers who seek modern apprenticeship funding support from Skills Development Scotland.

### **\*[S6M-03841](#) Dean Lockhart: UK Government Funding for Stirling Albion Grassroots**

**Football**—That the Parliament welcomes news that Active Stirling, and its affiliated football club, Stirling Albion Football Club have received funding of £100,000 from the UK Government to improve grassroots football facilities; understands that the football club will use the funding to replace the current 3G pitch at Forthbank; further understands that this will enable the Stirling Albion FC junior academy and community teams continued access and allow for growth in women and girls football; understands that the club has further plans to grow more community projects including para football, veterans football and other community initiatives such as drug recovery programmes; further understands that Stirling Albion also plans to use this new 3G pitch as part of its successful Modern Apprenticeship Programme, and congratulates all recipients of this round of funding from the UK Government.

**\*[S6M-03835](#) Murdo Fraser: Hospitality Rising** —That the Parliament supports the UK-wide Hospitality Rising initiative; understands that the initiative has already won official support from the Hospitality and Tourism Sector Skills Board (HTSB); further understands that the initiative aims to get people into hospitality and fill some of the 400,000 current vacancies across the hospitality sector in the UK, while encouraging those who do so, to see it as a realistic and rewarding career, and wishes the initiative all the best.

**\*[S6M-03832](#) Pam Gosal: Bake for Bliss Charity Coffee Morning Raises £1,050**—That the Parliament applauds the efforts of Kelly McAuley's Bake for Bliss coffee morning held in Helensburgh, which raised £1,050 for the charity, Bliss; understands that the charity is dedicated to helping sick or premature babies and works to support families with a baby in neonatal care; further understands that the money was raised through home baking, stalls, games, face painting and a raffle, and appreciates the efforts of Kelly in supporting the charity and helping Bliss to continue championing what it believes are the rights of premature or sick babies to receive the best care, through empowering families, influencing policy and practice and enabling research.

**\*[S6M-03831](#) Colin Beattie: Abused Men in Scotland Charity Receives £177,257 National Lottery Community Fund Grant** —That the Parliament welcomes the £177,257 in grant funding for the charity, Abused Men in Scotland, which was provided by the National Lottery Community Fund; understands that the funding will be used to implement a new community-focussed delivery model, supporting men who are experiencing domestic abuse and will provide a further 49 hours cover on its helpline; further understands that the funding will also help to recruit an additional 10 helpline support volunteers, with 15 Local Hero volunteers to be recruited throughout the country to deliver outreach and build connections in their local areas; believes that the organisation delivers a vital service throughout the country; thanks the organisation for its continued hard work, and wishes it the best going forward.

**\*[S6M-03829](#) Stuart McMillan: Morton in the Community Helping Young People Gain Employability Skills**—That the Parliament welcomes Morton in the Community's Get Started with Football initiative, which aims to help 16- and 17-year-olds develop essential employability skills and earn coaching accreditations at the same time; understands that the Ton's charity arm has worked with local high schools and Skills Development Scotland to identify individuals that, it believes, would benefit from taking part; understands that throughout the three-week course, participants worked on earning their SFA introduction to coaching qualification, as well as pre-requisite qualifications that centre on child wellbeing and mental health; further understands that

participants also completed a customer service course and worked on their CVs and cover letters; believes that football, and sport more generally, can be a great way to engage people with a range of topics, including employability; understands that The Prince's Trust helped Morton in the Community fund these sessions, and that they are looking to build on this and deliver more sessions in the future; thanks the charity for what it sees as its commitment to having a positive impact on the local community, and wishes them all the best as they continue to deliver a range of projects in Inverclyde.

**\*[S6M-03828](#) Stuart McMillan: CalMac Donates Laptops to Help Tackle Digital Poverty—**That the Parliament commends CalMac on donating 55 laptops to Belville Community Garden Trust so that they can be refurbished and provided to people in the community as part of their digital device refurbishing project; considers that the Gourock-based ferry operator's donation will help tackle digital poverty and social isolation, while also diverting electronics away from landfill; commends Belville for its efforts to tackle poverty and isolation in all its forms; thanks CalMac for what it sees as its commitment to support local projects in Inverclyde, and wishes both organisations all the best for the future.

**\*[S6M-03827](#) Stuart McMillan: Port Glasgow Voluntary Transport Group Receives £10,000—**That the Parliament congratulates Port Glasgow Voluntary Transport Group on receiving £10,000 from Strathclyde Partnership for Transport to support its service; understands that the funding is part of a £2.1 million fund to support community transport projects across the region; further understands that Port Glasgow Voluntary Transport Group will use the funding to continue to provide accessible, affordable transport for socially or economically disadvantaged groups, voluntary and third sector organisations in Inverclyde; commends the Port Glasgow group for their efforts to provide this service, and wishes them all the best for the future.

**\*[S6M-03825](#) Stuart McMillan: Dr Sandhu-Ram Gupta MBE Recognised by Gourock Rotary Club—**That the Parliament commends Dr Sandhu-Ram Gupta MBE on his commitment to improving the eyesight of people living in the poorest parts of the world; understands that as an eye surgeon, Dr Gupta has carried out missions across the globe, setting up camps to change lives by removing cataracts and treating other eye conditions; further understands that on top of his charity efforts abroad, Dr Gupta has raised thousands of pounds to fund equipment and services in the Inverclyde Royal Hospital, where he has worked for almost 30 years; understands that Gourock Rotary Club has teamed up with Dr Gupta's family to launch a new Young Citizen Award in his honour, in the hope that this will encourage the next generation of philanthropists in the community; notes that Dr SR Gupta MBE and Gourock Rotary Citizens Award has been sponsored by Greenock-based export firm, PG Paper, which is run by Dr Gupta's son, Puneet along with his wife Poonam; encourages people to nominate young people aged between nine and 24, who are champions in their school or local community; believes that this award is a fitting
