Members' Business motions that have achieved cross party support

***[S6M-17103](#) Katy Clark: Recognition of the State of Palestine**—That the Parliament notes the calls from people in the West Scotland region and across the country for the UK Government to recognise the State of Palestine; understands that 146 member states of the UN recognise Palestine as a sovereign state, encompassing the West Bank and the Gaza Strip; believes that independent Palestinian statehood on the basis of a free people with rights to self-determination and territorial integrity is an inalienable right and requirement for permanent peace between Palestine and the State of Israel; expresses grave concern over what it sees as the humanitarian catastrophe in Gaza and the Israeli military escalation in the occupied West Bank, including the deployment of tanks into Jenin for the first time in over two decades, and notes the view that a much-needed pathway to a sustainable and peaceful solution must be rooted in accountability and justice, upholding the dignity of both Israeli and Palestinian civilians.

***[S6M-17073](#) Emma Harper: World Asthma Day 2025**—That the Parliament welcomes World Asthma Day 2025, which takes place on 6 May; recognises that the theme for World Asthma Day 2025 is "Make Inhaled Treatments Accessible for ALL", which is set by the Global Initiative for Asthma (GINA); understands that around 360,000 people are living with asthma in Scotland, including 72,000 children, and that it is the most common respiratory condition impacting people of all ages; notes the support for efforts to improve asthma diagnosis and treatment, including receiving the basic elements of asthma care, which are an annual review, inhaler technique check and written action plan; regrets, however, that only 24% of people with asthma reported receiving all three basic elements, according to Asthma + Lung UK's Life with a Lung Condition survey; notes that new asthma guidelines were launched in 2024 by the Scottish Intercollegiate Guidelines Network (SIGN), National Institute for Health and Care Excellence (NICE) and British Thoracic Society (BTS); understands that 2023 saw the highest number of asthma deaths recorded in Scotland in over 30 years, and notes the support for the campaigns and advocacy from charities such as Asthma + Lung UK Scotland to improve asthma prevention, diagnosis, treatment and care across the country, including in the South Scotland region.

***[S6M-17147](#) Sarah Boyack: Scottish Youth Parliament's Work on Transport**—That the Parliament acknowledges the efforts of the Scottish Youth Parliament's Transport, Environment and Rural Affairs Committee to remove barriers to young people accessing public transport; notes the view that public transport should be affordable, accessible and reliable for young people across Scotland, including in the Lothian region; further notes the view that particular action should be taken for young people in rural and island communities who, it considers, currently benefit less from the Young Persons' (Under 22s) Free Bus Travel scheme due to limited bus services and infrastructure in their areas; recognises what it sees as the benefits that affordable, accessible and reliable public transport have for young people's access to social, educational, youth work and employment opportunities, and notes the support for further action to be taken to improve young people's access to public transport.

***[S6M-17145](#) Christine Grahame: 30th Anniversary of Eco-Schools and Success for St Andrew's RC Primary School in Gorebridge**—That the Parliament congratulates St Andrew's RC Primary School in Gorebridge on its commendation for learning for sustainability in the international environmental Eco-Schools programme, by the environmental charity, Keep Scotland Beautiful; understands that St Andrew's RC Primary School has gone above and beyond in its Eco-Schools activities across all of the required categories; further understands that Eco-Schools is currently celebrating its 30th anniversary, and that it is the largest sustainable schools programme in the world, operated internationally by the Foundation for Environmental Education and delivered by Keep Scotland Beautiful, and considers that such schemes are helpful in encouraging young people to take an interest in environmental issues.
