*S6M-18531 John Swinney: Motion of Condolence —That the Parliament expresses its profound sadness at the death of George Reid; extends its deepest sympathy and sincere condolences to his family and friends; appreciates the many years of public service that he gave as an MP, MSP, Presiding Officer, and Lord Lieutenant; recognises the substantial contribution that he made to the establishment of the Scottish Parliament and the securing of its place in the life of the nation, and acknowledges his humanitarian work over many decades and the high regard in which he was held by colleagues across the world.

*S6M-18527 Gordon MacDonald: Vision for New Centre for Sustainable Brewing and Distilling at Heriot-Watt University—That the Parliament welcomes the commitment from Heriot-Watt University, in Edinburgh, on the economic importance of brewing and distilling in Scotland by seeking to raise £35 million to build a new Centre for Sustainable Brewing and Distilling (CSBD); understands the centre will be a new state-of-the-art version of the current International Centre for Brewing and Distilling (ICBD), which it understands is a world leading educational establishment delivering undergraduate and graduate courses; notes that the CSBD will embrace the latest green technologies and sustainable practices, ensuring that the university continues to lead the world in securing a future for both industries; recognises what it sees as the legacy and impact of Heriot-Watt University on the industries of brewing and distilling for more than 120 years, establishing both industries as key economic drivers, and commends what it considers to be the first-class teaching, innovation and sustainable methods of working at the ICBD, which has contributed to the success of brewing and distilling not only in Scotland but across the continents of Europe, the Americas and Asia.

*S6M-18523 Craig Hoy: Urgent Action to Dual the A75—That the Parliament considers the A75 to be a critical economic and strategic link between south-west Scotland and the rest of the UK

and Northern Ireland; notes with concern what it sees as the dangerous under-investment in the road for decades; further notes the belief that the road's single carriageway sections are a daily safety hazard, a brake on the regional economy and a growing deterrent to business and tourism throughout Dumfries and Galloway; notes the support for urgent action to fast-track dualling; further notes suggestions to cut red tape, speed up environmental assessments, and unlock private investment to deliver the project, and notes the calls on the Scottish Government to end delays and commit to a clear timetable for upgrades.

*S6M-18539 Martin Whitfield: Green Flag Community Award for Ormiston Park—That the Parliament notes the success of Ormiston Park in being named the only park in East Lothian to receive the Green Flag Community Award for 2025-26, recognising it as one of the best-managed green spaces in the UK; understands that Green Flag Awards are granted following an assessment process carried out by environmental charity, Keep Scotland Beautiful, which evaluates green spaces on eight key criteria, and commends The Friends of Ormiston Park, other groups in the village, including Ormiston Blooms Together and Lily's Ormiston CIC, as well as East Lothian Council, for all the hard work that they have undertaken, which has led to Ormiston Park again securing this prestigious award.

*S6M-18538 Liam McArthur: Orkney Kickboxer, Amy Golder, Wins Four Medals at Kickboxing Open World Championships—That the Parliament congratulates Orkney kickboxer, Amy Golder, on winning four medals at the Kickboxing Open World Championships, which took place in Barnsley, Yorkshire on 3 August 2025; understands that Amy won three gold medals and one silver in the 55kg, 60kg, 65kg and open weight categories; further understands that Amy competed and won against competitors from the USA, England and Wales; acknowledges that Amy's success at this competition is just the latest in a long line of such successes at an international level, having been named world champion 49 times; understands that Amy first took up kickboxing after a visit to her school by a local kickboxing sensei as a child, and now is able to visit schools in Orkney to share her love for the sport with young people as head kickboxing instructor and coach; welcomes Amy's commitment to passing on her skills and passion for kickboxing, and wishes Amy continued success in her future kickboxing career.

*S6M-18537 Pauline McNeill: Welcoming the Introduction of Firework Control Zones in Glasgow —That the Parliament welcomes the introduction of Firework Control Zones in Glasgow, including in Broomhouse, Govanhill and Pollokshields, which will prohibit the private use of fireworks between 1 and 10 November each year; notes that these measures, enabled by the Fireworks and Pyrotechnic Articles (Scotland) Act 2022, aim to improve public safety, reduce antisocial behaviour, and minimise harm to people, animals, and the environment; further notes what it sees as the strong public support for these zones, following consultation with local communities and emergency services; calls for the zones to be monitored for effectiveness and for clear, timely communication to residents to ensure proper enforcement, and encourages other local authorities to consider similar measures where appropriate.

*<u>S6M-18536</u> Kevin Stewart: Celebrate Aberdeen—That the Parliament welcomes the news that the Celebrate Aberdeen Awards will be returning for its sixth year in 2025; understands that the awards, which recognise the positive impact that individuals, organisations and volunteers in the

third sector make to thousands of lives across Aberdeen city and Aberdeenshire, will be held at the Chester Hotel in Aberdeen on 1 November; notes that awards will be handed out in eight categories, including Community Impact of the Year, Large and Small Organisation of the Year, Volunteer/Fundraiser of the Year, Young Supporter of the Year, Campaign or Event of the Year, Team of the Year and Heart of the Community, and will be open to all third sector organisations in Aberdeen city and Aberdeenshire; further notes that CNR International and CNOOC International will be returning as Gold sponsors, with other partners including Cala, Aberdeen Inspired, Hampton, Harbour Energy and Dax Group, ensuring that all finalists and their supporters will be able to attend the gala event free of charge; believes that these awards are a fantastic way to give recognition to those who give so much time and energy in the pursuit of helping others, and looks forward to seeing which worthy organisations and volunteers are nominated for each category.

*S6M-18534 Mercedes Villalba: EIA Review of CCS and Upstream Emissions by SSE Thermal Peterhead Power Station—That the Parliament welcomes reported research from Carbon Tracker into the environmental impact of a proposed SSE Thermal combined cycle gas turbine power station at Peterhead; notes the UK Supreme Court decision in R (on the application of Finch) v Surrey County Council and the updated Institute of Environmental Management and Assessment (IEMA) guidance, which, it understands, led to the need for SSE Thermal to review its environmental impact assessment (EIA) of the project; understands that the research estimated that greenhouse gas emissions would be more than five times greater than the initial estimates, due to the exclusion of upstream emissions related to the supply of natural gas, emissions during periods of unplanned carbon capture facility outage, and significant uncertainty around the carbon capture rate of the facility; further understands that the proposed gas-fired power station would only create up to 50 operation jobs at the plant over its lifetime, and believes that a just transition for workers and communities in north-east Scotland must deliver mass high-quality, secure and unionised jobs in green industries, including renewable energy development, oil and gas decommissioning, and infrastructure expansion and improvement. R

*S6M-18533 Jackie Baillie: Commending the Surgical Day Bed Unit at the Vale of Leven Hospital for the Opening of its New Hospital Garden Space—That the Parliament commends the Surgical Day Bed Unit at the Vale of Leven Hospital on the opening of its hospital garden area; understands that this welcoming space has been created to provide a place of comfort and calm for patients, staff and visitors at the hospital; recognises that the Surgical Day Bed Unit has further demonstrated its ongoing commitment to patient care and community support through donations to local food and toy banks, and thanks the unit for its ongoing expert and compassionate care of local people.

*S6M-18532 Kenneth Gibson: Black Lives Matter: Sudan, the "World's Largest and Most Devastating Humanitarian Crisis"—That the Parliament notes that, while the world's focus is on Gaza and Ukraine, a bloody civil conflict rages in one of Africa's poorest countries, Sudan, which it understands has cost at least 150,000 lives since April 2023; condemns the reported atrocities committed in Darfur by the Rapid Support Forces (RSF) and allied militias; recognises credible accounts from Human Rights Watch and other sources documenting systematic terror and violence against civilians on a colossal scale; understands that there are reports from the United Nations Children's Fund (UNICEF) in March 2025 of mass rape, including the rape and sexual assault of children, with 221 cases recorded in 2024 across nine states of Sudan, of which 16 involved children under five, including four infants who were just one year old, with approximately two thirds of the victims being female; further understands that UNICEF and other UN agencies

have highlighted the severe psychological impact of such violence on children, including trauma leading to attempted suicide and self-harm; acknowledges that Sudan is facing what in March 2025 Catherine Russell, head of UNICEF, described to the UN Security Council as the "world's largest and most devastating humanitarian crisis," with nearly 25 million people experiencing extreme hunger, over 30 million people, including 16 million children, requiring aid, 1.3 million children living in famine conditions, and 770,000 suffering from severe acute malnutrition, with possibly as many as 522,000 having already died; is appalled by reports that almost nine million people are internally displaced, with over 3.5 million refugees; acknowledges the findings of Human Rights Watch that thousands of Massalit and other non-Arab black civilians were killed in El Geneina in a campaign of ethnic cleansing intended to permanently displace them, estimating between 10,000 and 15,000 people killed, with targeted massacres, rapes, and torture; understands that a subsequent investigation by the International Criminal Court found "reasonable grounds to believe" that both the RSF and Sudanese Armed Forces committed war crimes; notes the determination of the United States Government in January 2025 that the RSF and allied militias committed genocide through systematic killings of men and boys, including infants, targeted sexual violence against women and girls, attacks on fleeing civilians, and obstruction of humanitarian aid; understands that the US and other countries have imposed sanctions on RSF commander General Mohamed Hamdan Dagalo, and Sudanese Armed Forces leader General Abdel Fattah al-Burhan; expresses solidarity with the victims and survivors of these atrocities, and the severe physical, psychological, and social harm endured, particularly by children, and urges the UK Government and international community to seek a swift resolution to the conflict and ultimately support independent investigations, ensure accountability for perpetrators, and take all necessary measures to prevent further atrocities in Sudan.

*S6M-18530 Emma Roddick: Congratulations to Inverness Scout Leader, Daisy Milne, on Representing Scotland and the UK at the World Scout Moot—That the Parliament congratulates Daisy Milne, 18, who is a Scout leader from Inverness, on being chosen to represent Scotland and the UK at the 16th World Scout Moot in Portugal; recognises that she engaged with Portuguese communities and culture during the event; acknowledges that the World Scout Moot includes a four-day expedition during which participants form international groups and follow one of 100 routes through remote parts of Portugal; observes that she is one of nearly 500 UK Scouts who travelled to take part, among approximately 9,000 Scouts worldwide aged 18 to 25, and highlights that 2025's theme was "engage", encouraging cross-cultural exchange, understanding and friendship.

*S6M-18528 Kenneth Gibson: Ardrossan's Vladyslav Shopynskyi is British Under-8 Chess Champion—That the Parliament congratulates seven-year-old Ukrainian-born Vladyslav Shopynskyi, from Ardrossan, on being crowned the British Under-8 Chess Champion; acknowledges his outstanding performance representing Scotland at the Glorney Cup in Wales from 28 to 30 July 2025, where he competed in the under-12 team and remained undefeated; considers that his achievements at both the Glorney Cup and the British Chess Championship in Liverpool, where he earned one of the most prestigious junior chess titles in the UK by winning the

*S6M-18526 Pam Gosal: Asda Foundation Grants Supporting Local Groups Across the West Scotland Region—That the Parliament commends the meaningful contributions made by the Asda Foundation in strengthening communities across Scotland through its grant programme; notes with appreciation the involvement of Asda stores in Bearsden, Bishopbriggs, Clydebank and Irvine in supporting locally led initiatives; highlights recent funding awarded to a number of groups, including £1,800 to Families of Auchinairn Coming Together, £3,000 to Ramekin & Rolling Pin of Kirkintilloch, £1,000 to New Roots Initiative Ltd of East Dunbartonshire, £1,000 to Dalmuir Barclay Church Mini Youth Group, £1,000 to Dalmuir Barclay Church, £3,000 to Ayrshire Communities Education and Sport, £3,000 to Dalry Community Sports Club, and £982 to Woodland Wakeup; recognises that this funding helps local organisations deliver services, respond to social challenges, and create inclusive spaces for residents of all ages, and congratulates the recipients on their positive impact within their communities.

*S6M-18525 Bill Kidd: Condemning Radioactive Contamination on Scottish Shores—That the Parliament condemns the UK Government after radioactive contamination was reportedly found in Loch Long; acknowledges recent reports of radioactive leaks from the Royal Naval Armaments Depot (RNAD) Coulport, which it considers to be a direct consequence of decades of a nuclear weapons policy which is forced on Scotland by the UK Government; further acknowledges reports that highlight serious issues at the base, attributed to burst pipes and significant shortfalls in maintenance within the base's infrastructure; considers that the reports of repeated incidents and maintenance failures are deeply alarming; understands that emissions of tritium into the air from Coulport have reportedly doubled between 2018 and 2023; believes that the continued occurrence of such incidents raises serious questions about the long-term environmental impact on Loch Long and the surrounding ecosystem; considers that Loch Long is a vital natural resource, and that the thought of it being exposed to unnecessary radioactive waste is profoundly troubling; calls for a comprehensive and independent investigation, in the form of a fully transparent and independent inquiry, into the root causes of these reported recurring leaks, the state of infrastructure at Coulport, and the effectiveness of current oversight mechanisms; further calls for swift and verifiable remedial action, including a clear timeline and commitment to upgrading the ageing infrastructure at Coulport to prevent any future radioactive discharges, along with regular, public updates on progress; calls for enhanced transparency and communication, with greater openness from the Ministry of Defence regarding any incidents, including immediate and detailed public disclosure of all radioactive discharges and their potential impacts, as well as strengthened regulatory oversight and a review of the current regulatory framework for military nuclear facilities to ensure that they are subject to the same stringent environmental controls and accountability as civilian nuclear sites, and believes that the local community deserves to live without concerns of any radioactive contamination from nearby military operations.

*S6M-18524 Mercedes Villalba: Ending Fuel Poverty and Reliance on Gas Heating—That the Parliament believes that the path to ending fuel poverty in Scotland requires new, sustainable renewable energy and mass public retrofitting of homes and buildings, not further gas extraction and domestic gas heating; notes recent analysis by Uplift and the End Fuel Poverty Coalition showing how North Sea gas extraction will be unable to meet national domestic heating demand

from 2027, and that the UK will be more than two-thirds reliant on foreign gas imports by 2027, and is forecast to be 94% reliant by 2050; understands that North Sea natural gas sold on international markets exposes UK workers and households to volatile energy prices amidst the ongoing energy and cost of living crises, and that previous polling by the End Fuel Poverty Coalition shows that 67% of the UK public are concerned about the UK's reliance on oil and gas; opposes the licensing and approval of new UK gas fields, which, it believes, will not reduce dependence on imports or lower energy prices, and will only benefit private, multi-national fossil fuel companies; supports the expansion of publicly and community-owned wind, solar, tidal and wave energy generation, and the prioritisation of measures including retrofitting heat pumps, insulation, ventilation, green spaces, greener buildings, and local and district heat networks to tackle fuel poverty, and calls on the Scottish Government to work constructively with the UK Government to meet legally binding climate obligations and net zero goals, to end reliance on domestic gas heating, and to end fuel poverty in Scotland.

*S6M-18522 Paul McLennan: Paying Tribute to Pippa and Alasdair Swan of Dunbar Community Council—That the Parliament recognises the exceptional contribution of Pippa and Alasdair Swan to Dunbar Community Council over the past decade; notes that Pippa joined the council in 2014, becoming chair in 2018, while Alasdair has served as treasurer for approximately 10 years; commends their leadership in reviving Dunbar Civic Week, supporting the town centre economy, and overseeing a range of projects, including the restoration of the 25-pounder gun, the establishment of the book barn in Lauderdale Park, and improvements to the High Street; thanks them for their commitment, energy and practical focus, and wishes them well for the future.

*S6M-18521 Alasdair Allan: Isle of Lewis Cancer Research UK Shortlisted for Make a Difference Award —That the Parliament congratulates the Isle of Lewis Cancer Research UK Committee on being shortlisted for BBC Radio Scotland and BBC Radio nan Gàidheal's Make a Difference Award; acknowledges that the committee celebrates its 50th anniversary in 2025, and commends and thanks the Committee for its tireless work in raising over £1.2 million through community-driven events over the years to help beat cancer for good.

*S6M-18520 Ross Greer: Killing of "Palestinian Pele", Suleiman al-Obeid, by Israeli Occupation Forces—That the Parliament is deeply concerned by the reported murder of Palestinian footballer Suleiman al-Obeid, known as the "Palestinian Pele", who was reportedly killed by Israeli occupation forces during an attack on civilians waiting for humanitarian aid; notes with distress the reports that over 400 Palestinian footballers have been killed by what it sees as Israel's genocidal assault on Gaza since 2023, and calls on UEFA and FIFA to suspend Israeli national teams and clubs from all international football competitions, including the World Cup, until the occupation of Palestine is ended.

*S6M-18518 Kenneth Gibson: Environmental and Public Health Risks from Radioactive Discharges into Loch Long—That the Parliament notes with concern the reported findings of the Scottish Environment Protection Agency (SEPA) regarding repeated leaks of radioactive waste water from the Coulport nuclear weapons facility into Loch Long in recent years; understands that SEPA attributes these incidents to shortfalls in maintenance and asset management, including the failure to replace ageing infrastructure, with up to half of the components at the base reportedly

beyond their design life at the time of the leaks; acknowledges that there was a pipe burst in 2010, and that flooding in a nuclear weapons processing area in August 2019 led to the release of low levels of tritium, a radioactive substance used in warheads, into the marine environment; is aware that there were reportedly two further pipe bursts in 2021; considers that repeated failures to maintain equipment, including the "sub-optimal" plans to replace 1,500 old pipes, pose serious risks to environmental and public health; believes that the lack of transparency and accountability in managing these risks is unacceptable, and calls on the UK Government to ensure that robust safeguards are in place to protect communities and ecosystems; believes that the closure of this facility would be better still, and urges the UK Government to remove all nuclear weapons from Scotland at the earliest possible date.
