***[S6M-18246](#) David Torrance: NHS Fife Awarded University Health Board Status**—That the Parliament congratulates NHS Fife on being officially awarded University Health Board status, becoming the first NHS board in over 50 years to receive this prestigious designation; recognises that NHS Fife now joins a select group of prescribed NHS boards, alongside NHS Grampian, NHS Greater Glasgow and Clyde, NHS Lothian and NHS Tayside; commends the hard work and dedication of all NHS Fife staff; believes that their collective commitment to education, research and innovation made this milestone possible; considers that the strengthening of NHS Fife's partnership with the University of St Andrews will further enhance the training of future healthcare professionals and support research that will benefit patients in Fife and beyond, and welcomes the wider benefits that it believes that this designation will bring to both healthcare delivery and professional development across the region.

***[S6M-18294](#) Keith Brown: 400th Anniversary of the Baronetcy of Nova Scotia and Menstrie's Role in Scotland-Canada Relations**—That the Parliament celebrates the 400th anniversary of the Baronetcy of Nova Scotia, which was established in 1625 by King James VI and I as part of a wider vision to encourage Scottish colonisation and influence in North America; recognises what it sees as the pioneering role of Sir William Alexander of Menstrie, whose vision and leadership laid the foundations for the colony of Nova Scotia and whose legacy is reflected today in the province's name, coat of arms and flag; acknowledges the enduring cultural and historical links between Scotland and Canada, which were shaped, it believes, in part by Sir William's legacy, and recognises what it sees as the honour represented through the naming of the Canadian Coast Guard ship *CCGS Sir William Alexander*; commends the village of Menstrie, in Clackmannanshire, for its ongoing efforts to commemorate and celebrate this legacy, including through Menstrie Castle, which was Sir William's ancestral home, and where a permanent exhibition and newly unveiled plaque mark the connection between the Wee County and Nova Scotia; welcomes the international conference, hosted by the University of Stirling, to explore the history and legacy of the Baronetcy, which aims to delve into the impact of the Baronetcy on both

Scottish and Canadian societies and, by bringing together scholars from both countries, to foster a deeper understanding of their shared history and cultural ties; acknowledges the support of heritage groups, such as the Saltire Society, and the participation of Canadian representatives in this anniversary year, and calls for continued recognition and celebration of what it sees as this important chapter in Scottish history, to ensure that Menstrie's place in the story of Nova Scotia remains widely known and appreciated as a lasting symbol of Scotland's global influence.

***[S6M-18293](#) Alexander Stewart: The 167th Alva Games—**That the Parliament acknowledges that Clackmannanshire is preparing for one of its biggest summer events, as the Famous Alva Games return in July 2025; considers that 2025 marks the 167th edition of the games, which begin on 12 July at Johnstone and Cochrane Parks; believes that high numbers have entered for the 400m, 800m, 1600m and 3200m events, which are reportedly the very best in many years; acknowledges that the organisers are hoping to build on the hugely successful games day in 2024, which saw the inaugural female heavyweight competition, joining the junior competition, which began in 2023; understands that games organisers say that both classes were contested by the best of the athletes in both categories; considers that they are both a very welcome addition to the programme; believes that, in the tradition of the games, a guest of honour has been selected for the 2025 Alva Games, and that long-term supporter and well-known Clacks figure, John MacPherson, has been given the honour as a former Deputy-Lieutenant for Clackmannanshire, until his retirement in April 2025; understands that John will lead the front of the parade and be piped onto the field by the Alloa Bowmar Pipe Band, which, it notes, is ever-present at Johnstone Park, and wishes everyone involved the very best of wishes for a highly successful day.

***[S6M-18289](#) Rona Mackay: Historic Church Given back to Community under Ownerless Property Transfer Scheme**—That the Parliament celebrates what it believes to be a landmark moment in Scotland's heritage regeneration journey, with the formal transferral of a 200-year-old church in the Strathkelvin and Bearsden constituency to the local community; understands that Campsie High Kirk, at the heart of Lennoxton, is to be transformed into a community arts hub for the benefit of local people; notes that the move is the culmination of a flagship case for the new ownerless property transfer scheme (OPTS), which was launched in 2024 by the King's and Lord Treasurer's Remembrancer (KLTR); believes that the church, one of Scotland's best known kirks, was officially handed over by KLTR, John Logue, to East Dunbartonshire Provost, Gillian Renwick, at a public ceremony on 9 July 2025; praises community organisation Friends of Campsie High Kirk for its tenacity in putting forward the case to rescue the church, which had lain empty without an owner for years after a fire in 1984, which led to the community organisation acquiring the building from the KLTR for the sum of £1 in May 2025; recognises the role of the OPTS in providing opportunities for properties that have fallen to the Crown, as ownerless, to be brought back into purposeful use for the benefit of local communities, therefore empowering local people, and sends its very best wishes for the future of the former kirk to boost the Lennoxton area, both culturally and economically.
