S6M-17457 John Swinney: Commemorating the 80th Anniversary of Victory in Europe (VE) Day—That the Parliament marks the 80th anniversary of Victory in Europe (VE) Day, which took place on 8 May 1945; remembers the 380,000 UK Armed Forces personnel, including 57,000 Scots, and over 67,000 civilians who lost their lives during the conflict; commemorates the service and pays tribute to the sacrifices of those individuals from across Scotland and the UK, the Commonwealth and the Allied Nations, which ensured the peace and freedoms that are enjoyed today; appreciates the efforts of Legion Scotland and Poppyscotland to mark the occasion, including a national commemorative concert held in Edinburgh on 6 May 2025, Scotland's Salute to VE Day, which was supported by the Scottish Government, and commends the work of both organisations and of veterans charities across Scotland in supporting the veterans of this conflict and their families, many of whom continue to be affected by the tragedy of war to this day.

#### Members' Business motions that have not achieved cross party support

\*S6M-17428 Karen Adam: Thomas Blake Glover, Fraserburgh's International Legacy—That the Parliament recognises what it sees as the extraordinary global contribution of Thomas Blake Glover, a pioneering Scottish merchant and industrialist, who was born on 6 June 1838 in Fraserburgh, at what is now known as Glover Garden on Commerce Street, and who was the son of the town's harbour master; acknowledges Thomas Blake Glover's key role in 19th century Japan, where he supported the Choshu Five, a group of young scholars whose work helped shape modern Japanese governance, industry and education, including the introduction of sign language; notes his pivotal contribution to the establishment of the Mitsubishi Corporation and his influence in the development of Japan's shipbuilding and industrial sectors; celebrates the enduring cultural and economic links between Scotland and Japan that it believes Thomas Blake Glover helped to foster, including the internationally renowned Glover Garden in Nagasaki; recognises the contemporary relevance of his legacy in Fraserburgh, where offshore wind turbines, visible from the coast and maintained at the harbour where Thomas Blake Glover's father served, include parts manufactured by Mitsubishi; acknowledges what it sees as this powerful link between Fraserburgh's maritime heritage and its current role in the global energy transition; welcomes the development of Fraserburgh's own Glover Garden as a symbol of education, pride and international friendship, and wishes every success to the organisers and attendees of the inaugural Thomas Blake Glover Festival, taking place on 8 June 2025, in the hope that it will become a lasting annual celebration of Fraserburgh's unique contribution to global history.

sweet, tropical and orchard fruit style, and that the Tomintoul Pedro Ximénez Sherry Cask Finish is a small batch single malt bottled in ex-bourbon American oak barrels, before marrying and finishing in hand selected Pedro Ximénez sherry butts sourced from Andalucía, Spain; recognises that 2025 will see Glencadam Distillery in Brechin celebrate its 200th anniversary, making it one of Scotland's oldest distilleries, with Tomintoul Distillery marking its 60th year, and wishes Angus Dundee Distillers continued success as it launches Glencadam and Tomintoul single malts in Tesco.

\*S6M-17440 Tess White: Southesk Primary School Pupils Crowned Sumdog Angus Champions—That the Parliament congratulates P5 pupils at Southesk Primary School in Montrose as they are crowned Sumdog Angus Champions; understands that Sumdog is an online learning resource, which captivates children and empowers teachers through interactive maths games and personalised learning experiences, with its curriculum-aligned content used as a valuable tool in supporting classroom learning and boosting children's confidence; notes that the Sumdog competition is designed to promote teamwork, creativity and a deeper understanding of core maths skills, delivered in a fun way with children engaging in a series of interactive challenges to test their knowledge and problem-solving abilities; applauds the pupils in Southesk Primary School's P5 class who stood out in the competition with their exceptional performance, securing the title and the coveted Sumdog trophy, and congratulates the pupils and staff as they celebrate their Sumdog victory.

\*S6M-17438 Patrick Harvie: Becky Sikasa, Scottish Act of the Year 2025—That the Parliament celebrates the success of the artist, Becky Sikasa, on winning the title of Scottish Act of the Year 2025 in the BBC Introducing Awards; understands that Becky has made Scotland her home since moving from Germany in 2012, and that she lives in Glasgow after studying music at Edinburgh Napier University, and has been impressing audiences in her adoptive home of Scotland, and internationally; notes that her music combines her vocals and her keyboard, guitar and violin skills; recognises that the prize includes professional recording sessions with BBC Radio Scotland and a coveted slot at TRNSMT, Scotland's biggest music festival; congratulates everyone involved in what was a competitive final with a very high standard set by all involved; further congratulates Becky on her achievement, and wishes her well in her music career.

Scotland, into the experience of diverse groups of people in relation to active travel and the barriers they face; notes that, according to the research, neurodivergent people face barriers, including transport poverty, exclusion from decision-making processes, difficulties with journey planning with inconsistent systems, and the overwhelming sensory load of busy travel spaces; further notes that the research has identified that LGBTQ+ people experience fears over personal safety; believes that including diverse voices in street and infrastructure design, and providing secure, low-cost, secure cycle storage would reduce the barriers to active travel, and calls on the Scottish Government to commit to continued investment in making active travel journey planning easy to understand and consistent, as well as the provision of wider, more even footpaths, safer cycling infrastructure, including on routes to schools, and specific support for learning to cycle.

\*S6M-17435 Claire Baker: Culross Primary School Wins in the Fife Category of a UK-wide The Big Walk and Wheel Competition—That the Parliament congratulates Culross Primary School on winning the Fife category of a UK-wide The Big Walk and Wheel competition; understands that the competition aims to encourage school children to walk, scoot or cycle to school between 24 March and 4 April 2025; celebrates that Culross came top in the Kingdom in its category with 84% of children taking part, making the school fifth in the Scottish table and eighth UK wide; believes that there are great benefits of walking, wheeling or scooting to school for children's health and wellbeing; notes that the school was presented with an award at a recent assembly, attended by the competition mascot, Fresh Air Frankie; recognises what it sees as the many benefits of healthy habits like sustainable travel making a positive difference to children's health, the environment and family finances; commends Fife Council on its reported focus on active travel, where it takes a key role in its local transport strategy, and acknowledges that children from all schools in Scotland are encouraged to continue their participation in active travel in May, which is national walking month.

\*S6M-17434 Bill Kidd: The Nook from Scottish Action for Mental Health (SAMH) —That the Parliament welcomes the announcement of The Nook, Scotland's first ever network of walk-in mental health support hubs, by Scottish Action for Mental Health (SAMH); believes that community and preventative support is essential to Scotland's mental wellbeing; commends the initiative for its intention to provide barrier-free access to mental health support, with no need to book an appointment, no need for referrals, and no waiting lists; understands that the SAMH HQ in Glasgow's city centre will be transformed into the first Nook, opening in Autumn 2025, with further Nooks planned for Aberdeen, Edinburgh, Inverclyde and Lanarkshire; further understands that SAMH is welcoming support from the public to help make this transformational approach a reality, and wishes SAMH well with its plans to ensure that people with mental health problems are able to ask once and get help fast.
