### **Motions for Debate**

\*S6M-17648 Gillian Martin: Growing Community-owned Energy in Scotland—That the Parliament believes that Scotland must increase community-owned energy production, and supports communities being aided to achieve this; welcomes that, since its inception, the Community and Renewable Energy Scheme (CARES) has advised over 1,300 organisations and provided over £67 million in funding to support over 990 projects; notes that the new Community Energy Generation Growth Fund will provide up to £8 million to boost community energy in Scotland, and believes that the development of renewables at all scales in Scotland should benefit consumers, communities and the economy.

#### Members' Business motions that have not achieved cross party support

\*S6M-17552 Michelle Thomson: 5G Connectivity for Scotland—That the Parliament notes the reported expansion of 5G connectivity across Scotland and the recent merger, approved by the Competition and Markets Authority in February 2025, between Vodafone UK and Three UK, which, it believes, facilitates one of the most competitive mobile providers in the UK; believes that wide-ranging, reliable mobile coverage, in all areas of Scotland, including in the Falkirk East constituency, and in both urban and rural areas, is important; notes the view that bringing 5G connectivity to 99% of the population, and 89% of Scotland's landmass, by 2034 would benefit people across Scotland, including businesses, public services and the economy; further notes the reported increasing demand on technological services, and reliance on connectivity, in the everevolving digital age; notes the view that an increase in the quality, reliability and capacity of 5G would have a positive impact, not just on daily life, but on key sectors across Scotland, such as healthcare, agriculture, tourism and energy; further notes the calls for the UK Government, Scotlish Government and local authorities to work across reserved and devolved powers to facilitate 5G infrastructure and reliable connectivity, and celebrates what it sees as the improvements being made towards improving 5G connectivity for the people of Scotland.

\*S6M-17523 Jeremy Balfour: National Epilepsy Week and Epilepsy Scotland's "A Seizure That Stole a Future" Campaign—That the Parliament recognises National Epilepsy Week, which

takes place from 26 May 2025, and its aim of raising awareness of epilepsy and its impacts on the lives of the 80,000 people in Scotland who live with the condition; notes with particular attention the launch of Epilepsy Scotland's campaign, "The Seizure that Stole a Future", which seeks to highlight the often unknown and devastating risk of Sudden Unexpected Death in Epilepsy (SUDEP); acknowledges the emotional toll that SUDEP takes on families and communities; notes the view that there is a need for greater awareness, research and open discussion to reduce its occurrence; commends Epilepsy Scotland for its continued work providing support, advice and specialist services to individuals and families affected by epilepsy across the country, including in the Lothian region, and congratulates the charity on its leadership in tackling stigma, improving care and advocating for a safer and more informed Scotland.

#### Other new and altered motions and amendments

\*S6M-17637 Mercedes Villalba: Recognising International Day for Biological Diversity—That the Parliament recognises International Day for Biological Diversity on 22 May 2025, and observes that the theme for 2025 is harmony with nature and sustainable development; notes that the Kunming-Montreal Global Biodiversity Framework, which was enacted to end and reverse the loss of nature within 25 years, contains 23 targets to be met by 2030 and five global objectives by 2050, including restoring 20% of degraded ecosystems and reducing the introduction or settlement of invasive alien species by 50%; understands that the Sustainable Development Goals connect to this framework, and that both agendas must advance together as they support one another, and believes that community initiatives, such as the Clepington Gardens Allotment Association in Dundee, which has worked for over a century to improve biodiversity, help to progress objectives outlined in the Sustainable Development Goals by alleviating poverty, reducing hunger, and promoting health and well-being.

\*S6M-17617 Alexander Stewart: Alloa Primary Teacher to Complete Cateran Yomp for Army Charity—That the Parliament welcomes the news that a Clackmannanshire School teacher is set to lead an expedition to walk continuously over 24 hours for charity; understands that Gordon Tibbetts of Park Primary, in Alloa, will team up with Andy Connor, a former Argyll and Sutherland Highlander, to tackle the Cateran Yomp on 7 June 2025; notes that this event will see the men trek through the Cairngorm mountains to complete courses at 22, 36 or 54 miles long; understands that they will be joined by a team of 18 from the Unit 32 Signal Regiment, based across Central Scotland, and that they are also looking to fundraise for the Army Benevolent Fund; notes that Gordon's aim is to develop the physical resilience, mental robustness and leadership qualities of the soldiers that he serves alongside in the Army Reserve, in addition to raising much-needed funds to help serving army personnel, veterans and their families; acknowledges that this is the third year in a row that the Park Primary teacher has tackled the Cateran Yomp; understands that the event is the toughest event of its kind, where every year, participants gather in the Scottish wilderness to battle through the foothills of the Cairngorm mountains, walking continuously for 54 miles over 24 hours, based on a well-known, long-distance military training march; notes that Gordon and Andy have set a £400 fundraising target for the Cateran Yomp but have already

\*S6M-17604 Finlay Carson: The Gralloch 2025 Attracts Huge Numbers to Galloway Forest Park—That the Parliament congratulates the organisers of The Gralloch 2025, one of the biggest gravel races in the world, which attracted 3,000 riders from across the globe from 35 nations; notes that, almost entirely off-road, riders tackled around 111km across the hills of the Galloway Forest Park in the Galloway and Southern Ayrshire UNESCO Biosphere on some of the best gravel in the UK at Gatehouse of Fleet on 17 May 2025; further notes that the race was watched by a similar number of fans, families and members of the public to witness this incredible celebration of gravel riding, a test of determination, skill and endurance against some of the most challenging conditions; understands that the event is Britain's first UCI Gravel World Series event and represents a serious challenge to racers to conquer a demanding off-road course on some of the finest gravel tracks in the UK; notes that the Union Cycliste Internationale (UCI) is cycling's world governing body, and that its Gravel World Series is the highest level series of events in the world; understands that the ambition is for the Series to attract all, from professional elite riders, through to older competitive riders, and to those who just want to finish; recognises that, based on the UCI's Gran Fondo series, the Gralloch provides a qualification pathway to the Gravel World Championships in September 2024; believes that the Gralloch is more than just a race but a gravel festival, welcoming all riders to experience the thrill of the growing sport, whether chasing victory or tackling the challenge at their own pace in the non-competitive Sportive; understands that the weekend was packed with shakeout rides, live music, an expo, great food and drink, camping and an electrifying village event that created an unforgettable atmosphere for riders and

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
