Members' Business motions that have not achieved cross party support

*S6M-19207 John Mason: Nature Champions Initiative—That the Parliament notes what it sees as the success of the Nature Champions initiative, established in 2013 and coordinated by Scottish Environment LINK, which encourages all MSPs to champion Scotland's species and habitats; recognises that more than 100 MSPs have become Nature Champions over the current parliamentary session, supported by 25 LINK member organisations, and that the initiative marked its 10th anniversary in 2023 with a public exhibition outside the Parliament, before being awarded the NGO Impact Award by the Chartered Institute of Ecology and Environmental Management in 2024; considers that the Glasgow Shettleston constituency, like the rest of Scotland, benefits from action to protect biodiversity; regrets reports that one in nine species are at risk of national extinction in Scotland; acknowledges that many MSPs will retire or not stand again at the 2026 election, creating a need for new members in the next parliamentary session to take up the role of a Nature Champion; welcomes that the initiative will be relaunched in the new session to provide that opportunity, ensuring continuity in raising awareness of Scotland's threatened species and habitats, and commends the cross-party and collaborative spirit that it considers has underpinned the initiative throughout its history.

*S6M-19194 Audrey Nicoll: Protecting Scotland's Rivers —That the Parliament believes that Scotland has abundant rivers and streams, which support a diverse ecosystem and are the lifeblood of the landscape and central to the nation's brand, economy and sense of place; considers that they are now one of the country's most nature-depleted and endangered habitats; believes that this has arisen from a range of factors, including major flood events, water scarcity and increasing temperatures; expresses its concern regarding what it sees as the devastating decline in the population of freshwater pearl mussels in Scotland's rivers, including the River Dee, which flows through the Aberdeen South and North Kincardine constituency; notes the commitment of organisations, including the James Hutton Institute, Dee Catchment Partnership, Dee District Salmon Fishery Board and Cairngorm National Park Authority, to make the freshwaters and freshwater pearl mussel population more resilient to extreme climate events; believes that there is an opportunity provided by the Natural Environment (Scotland) Bill to establish a legal framework for biodiversity targets, including in the freshwater ecosystem to ensure healthy invertebrate diversity as an integral part of a fully functioning ecosystem; welcomes the Programme for Government commitment to extend the Nature Restoration Fund to enable

funding of multi-year projects to help deliver the priorities set out in the Biodiversity Strategy, and commends everyone working to restore and protect Scotland's rivers.

Other new and altered motions and amendments

*S6M-19205 Paul McLennan: Condemnation of Israel's Interception of the Global Sumud Flotilla—That the Parliament condemns Israel's interception of the Global Sumud Flotilla. which it believes was a peaceful humanitarian convoy seeking to challenge the blockade of Gaza and deliver lifesaving supplies to civilians facing one of the most severe humanitarian crises in the world; understands that humanitarians and activists from over 40 countries, including the Scottish activists, Jim Hickey, Margaret Pancetta, Yvonne Ridley and Sid Khan, have been detained by Israeli forces; notes with alarm the reported use of force and obstruction by Israeli authorities; considers that these raise serious concerns under international law, particularly regarding the right to peaceful passage and the protection of humanitarian missions; opposes the continued blockade of Gaza, which, it believes has severely restricted access to food, medicine, fuel and clean water; understands that the deliberate denial of humanitarian aid might constitute a war crime under international law; notes that the humanitarian situation in Gaza has been described by international agencies as "catastrophic", with the civilian population, especially children, bearing the brunt of the deprivation; supports the calls of international leaders, legal experts and humanitarian organisations in urging for Israel to comply with the rulings of the International Court of Justice and to allow unimpeded humanitarian access to Gaza; reaffirms Scotland's commitment to upholding international law, defending human rights and protecting civilians in conflict zones, and calls on the UK Government to take all necessary diplomatic and legal measures to ensure accountability for violations of international law, to support future humanitarian missions seeking to alleviate suffering in Gaza and to stand in solidarity with efforts that promote peace, justice and the dignity of all people in the region.

*S6M-19204 Fulton MacGregor: Baby Loss Awareness Week 2025 —That the Parliament considers that Baby Loss Awareness Week, which takes place from 9 to 15 October 2025, is a vital opportunity to raise awareness of pregnancy and baby loss and to remember the lives of babies who have passed away too soon; notes that this event began in 2002 as a single awareness day, and has grown into a UK-wide week of reflection, remembrance and support for all affected by miscarriage, stillbirth and neonatal death; acknowledges that the week concludes with the event, the Wave of Light, on 15 October, during which families across the country light candles in memory of their babies, whether in private or by sharing publicly as part of a wider community of remembrance and solidarity; recognises the powerful role the week plays in breaking the silence and stigma that can still surround pregnancy and baby loss, while offering comfort and connection to grieving parents and families; notes that public buildings and landmarks across the UK will once again be lit in pink and blue to mark the week and increase visibility of this important issue; commends the dedicated work of Baby Loss Retreat, which is a Coatbridgebased charity founded by Julie and Bryan Morrison, for its continued support to families navigating the trauma of baby loss; recognises the charity's efforts to provide spaces for healing, counselling and reflection; acknowledges the significance of the Baby Loss Memorial Book, which was introduced in 2023 and provides bereaved families with a meaningful way to honour and remember their babies, and extends its heartfelt condolences to all those who have experienced the loss of a baby at any stage of pregnancy or shortly after birth.

*S6M-19202 Craig Hoy: Regretting Bank Closures —That the Parliament regrets the latest round of bank closure announcements from Bank of Scotland and other operators across Scotland and the UK; further regrets what it sees as the failure to properly consult with customers and local businesses before closure decisions are taken; urges all high street bank operators to consider adopting a "branch promise" to halt future closures and to prevent so-called banking deserts developing; expresses concern about the fragile future of rural banking, and calls on Link and Cash Access UK to do all they can to fully maintain access to cash and banking services when high street banks close branches.

67Z Ministers to consider public interest considerations in relation to buyers of large land holdings

- (1) A purported transfer of land by the owner, or a creditor in a standard security having a right to sell the land, is of no effect if the Scottish Ministers consider that the purported transfer would not be in the public interest and—
 - (a) section 67G applies to the land, or
 - (b) a lotting decision under section 67N applies to the land.
- (2) In considering whether the purported transfer would be in the public interest, the Scottish Ministers must have regard to the identity and management proposals of the person to whom the land is proposed to be transferred, including—
 - (a) the extent and location of any other land in Scotland for which the person holds a controlling interest,
 - (b) where the person is resident for tax purposes,
 - (c) any plans or proposals the person has for—
 - (i) the future management of the land,
