# Members' Business motions that have not achieved cross party support

\*S6M-18800 Liam Kerr: The Insights of the Report of the Energy Transition Institute at Robert Gordon University, Striking the Balance—That the Parliament notes the report, Striking the Balance, which was produced by the Energy Transition Institute at Robert Gordon University; understands that it provides predictions for the future of the offshore energy workforce in the UK, which, it states, employs around 154,000 people, including in the North East Scotland region; understands that the report states that a best case outcome could see a need for 210,000 roles in offshore energy production, but that this would only be achievable through the installation of a further 6GW approximately of offshore wind each year and by managing the decline of oil and gas production over a prolonged timeframe; notes the report's claim that the worst-case situation anticipates around 400 oil and gas job losses in the UK each fortnight across the next five years; acknowledges with concern the report's claim that, if Scotland does not pursue renewable activities comprehensively and oil and gas production continues to decline, employment across the offshore energy industry could drop from around 75,000 jobs in 2024 to a figure in the range of 45,000 to 63,000 in the initial years of the next decade; welcomes the growth predicted in the report of the number of offshore renewables jobs in the UK, notes with concern, however, the suggestion in the report that the sector will likely struggle to absorb the amount of former oil and gas workers before 2028; recognises the report's cautioning that a decrease in offshore energy jobs of nearly 20% could take place without decisive or prompt action, and commends the work of the Energy Transition Institute in producing what it sees as rigorous data regarding a pressing issue in Scotland.

\*S6M-18894 Kevin Stewart: Margaret Barr Fulton, the UK's First Qualified Occupational Therapist—That the Parliament recognises that it is 100 years since Margaret Barr Fulton MBE took up her role as an occupational therapist at what was then Aberdeen Royal Asylum, and is now known as Royal Cornhill Hospital; notes that Margaret, who was known as "Peg" to her friends, was the first qualified occupational therapist in the UK, having studied at the Philadelphia School of Occupational Therapists; understands that Margaret, who was 25 at the time, was able to shape the occupational therapy profession into what it is today, leading the development of classes in a newly developed army hut on the hospital grounds, and going on to lead exhibitions to give the rest of the medical world insights into her work and educate the public about mental illness; further understands that Margaret was a talented crafter in areas as broad as weaving, woodwork, bookbinding and jewellery-making, and used these talents to find ways to engage patients in whichever activities sparked their interest; notes that Margaret's numerous achievements throughout her 38-year career, including helping create the Scottish Association of Occupational Therapy, of which she served as secretary, treasurer and later chair, as well as being a founder of the World Federation of Occupational Therapists in 1952, serving as its inaugural president; believes that occupational therapy in Scotland and beyond owes a huge debt of gratitude to the pioneering work of Margaret, and is pleased that her memory lives on today thanks to a new plague at Royal Cornhill Hospital, as well as the Fulton Clinic and Memorial Garden.

# European Charter of Local Self-Government (Incorporation) (Scotland) Bill (M)
