**\*[S6M-20682](#) Christine Grahame: South of Scotland Business Survey**—That the Parliament notes the findings of the latest South of Scotland Business Panel Survey, which was published by the South of Scotland Enterprise (SOSE) in February 2026 and is based on responses from hundreds of businesses and social enterprises across the region, highlighting the resilience of the South of Scotland's business community and signs of stable performance and continued ambition for growth despite ongoing economic challenges; welcomes evidence that employers are continuing to create opportunities for graduates and apprentices, supporting skills development and future workforce growth; notes the role of the South of Scotland Business Panel in providing an annual assessment of business sentiment, priorities and challenges; commends SOSE for its ongoing support for businesses, social enterprises and community groups across the region, and welcomes continued economic momentum and inward investment in the South of Scotland.

**\*[S6M-20681](#) Pauline McNeill: Policing and Scotland's Mental Health Crisis**—That the Parliament understands that recently reported statistics indicate that Scotland's police officers are having to deal with almost 700 mental health-related incidents every single day; notes that between April and October 2025, Police Scotland officers responded to 122,735 incidents, which represents one in five of all incidents police officers attend; further notes that only 15% of these calls involve criminality and

that all of this comes at a time when police officer numbers have reportedly fallen by over 1000 since 2013; believes that expecting police officers to fill the gap of struggling and under pressure mental health and NHS services is neither credible nor desirable and is placing a huge strain on an already stretched police service, and calls on the Scottish Government and Police Scotland to take immediate action to address the mental health crisis by restoring community policing that is properly funded and locally accountable, reversing non-attendance policies for core incidents affecting safety and vulnerability, compelling community planning partners to adopt a multi-agency approach to community safety and prioritising psychological wellbeing as a core operational requirement.

**\*[S6M-20680](#) Richard Leonard: Congratulations to Woodhall, Faskine and Palacecraig Conservation Group**—That the Parliament congratulates the Woodhall, Faskine and Palacecraig Conservation Group on what it considers to be a magnificent campaign to protect 244 hectares of greenbelt land from development; welcomes the decision by North Lanarkshire Councillors to reject the application for development, which would have included two large units for storage and distribution space, as well as the decision by the reporter, who was appointed by the Scottish Ministers, to reject the appeal against the council's decision; notes that the area is an ideal place for walking, jogging and enjoying varied wildlife; recognises that the conservation group is made up entirely of volunteers who, through their passion, dedication and energy, built a campaign supported by thousands of local residents that saw off developers, who, it believes, would have destroyed this greenbelt in pursuit of profit; welcomes what it sees as a victory of organised people against organised money, and would further welcome consideration of the option of community ownership to further protect this greenbelt site for future generations to enjoy.

**\*[S6M-20679](#) Kevin Stewart: Welcoming Aberdeen DFN Project Search Recruitment** —That the Parliament welcomes the news that recruitment has opened at the University of Aberdeen for the DFN Project SEARCH's 2026-27 internship programme; notes that the award-winning, year-long employability initiative offers life-changing opportunities to 12 young people aged 16 to 24 in the north east of Scotland, who have learning disabilities or are on the autism spectrum; understands that, as well as real-life work experience, the scheme offers City & Guilds qualifications and tailored support designed to help participants move into sustained paid employment; further understands that an open day will be held on 5 February 2026, allowing visitors the chance to meet the team and access help with the application process; notes that applications are open until 16 March 2026 and final interviews are scheduled for 16 April 2026; believes that this programme will help participants gain real experience, build valuable life skills and take the next step towards a sustainable future; congratulates all those involved on their efforts in making these opportunities available, and hopes that the chosen participants thrive from the skills and knowledge that they gain from being in the scheme.

**\*[S6M-20648](#) Foysol Choudhury: Thank You to Fresh Start, Edinburgh**—That the Parliament celebrates Fresh Start, in Edinburgh, for its work in helping those previously homeless resettle in their new homes; believes that whilst a new home is of vital importance to the homeless, it can also present new challenges, including decoration, learning to shop, cooking for oneself and the acquisition of essential household items and white goods; understands that Fresh Start, which is made up of 22 permanent staff and 160 volunteers, helps previously homeless people manage all of these challenges, and offers advice, information and one-to-one support regarding key financial and housing issues; commends Fresh Start for also providing opportunities for its service users to volunteer and develop volunteer-led services; welcomes the recent time-limited extension of the Investing in Communities Fund; believes that Fresh Start and other organisations will have to reduce their support for those who need it the most if funding is not put on a more sustainable footing in years to come; records its significant gratitude to the staff and volunteers of Fresh Start, including Fay Wilson who has volunteered at Fresh Start for over 20 years, and wishes them the very best in their future endeavours.

The last lodging day for amendments at Stage 2 is four sitting days before the meeting at which those amendments will be considered (e.g. Wednesday for a meeting on Tuesday); at Stage 3 it is five days before. Amendments may be lodged until 2.30 pm on any sitting day, except on the last lodging day for each Stage, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.
