S6M-20146 Daniel Johnson: Securing a Long-term Home for Edinburgh South FC and Recognising the Important Role of Grassroots Football—That the Parliament recognises what it sees as the significant contribution that Edinburgh South FC (ESFC) Inch Park Community Sports Club makes to grassroots sport and community participation across the Edinburgh Southern constituency; notes that the ESFC is one of the largest community football organisations in the country, with over 1,000 players across 75 teams, and supported by more than 200 volunteers; understands that the area of Inch Park, which is known locally as the "nursery site" has been identified as the preferred location for a new all-weather pitch and new changing facilities to support year-round participation and reduce cancellations; acknowledges that ESFC's plans have received support from the SFA; notes calls encouraging more local authorities and leisure centres to work alongside football clubs to secure sustainable long-term homes for clubs; believes that good access to high-quality and affordable football facilities is essential to supporting participation, improving health and wellbeing and offering opportunities for young people in communities across Scotland, and recognises what it sees as the important role that grassroots football clubs play nationwide in fostering inclusion, developing talent and strengthening communities.

S6M-20738 Jackson Carlaw: Amendments to the Scottish Parliament Salaries Scheme—That the Parliament, in exercise of the powers conferred by sections 81(1), 81(5)(b) and 83(5) of the Scotland Act 1998 resolves that, with effect from the day of the poll at the first general election for membership of the Parliament following the day on which this Resolution is approved, the Scottish Parliament Salaries Scheme is amended as follows—

(a) for paragraph 2(2) substitute—

“For any period during which a salary is payable to a member of the Parliament pursuant to a resolution of the House of Lords relating to the remuneration of members of that House, the yearly rate of the salary payable by virtue of this Scheme to that member for that period shall be reduced by two-thirds.”

(b) after paragraph 2(2) insert—

“(2A) No salary shall be paid to a member of the Parliament in respect of any period in which the member is or was also a member of the House of Commons. This does not apply to any salary payable to a member of the Parliament in their capacity as the First Minister, a Scottish Minister, a junior Scottish Minister, the Lord Advocate, the Solicitor General for Scotland, the Presiding Officer or a Deputy Presiding Officer.

(2B) If remuneration is also payable to a member of the Parliament in respect of the same period under regulations made under section 11(1) of the Local Governance (Scotland) Act 2004 then the amount of salary payable to the member shall be reduced by the amount specified as payable to a councillor (who is not designated the Leader of the Council, the Civic Head or a senior councillor) by those regulations made under section 11(1) of the 2004 Act.”

(c) in paragraph 2(1), after “sub-paragraph (2)” add “, (2A) and (2B)”.

Members' Business motions that have not achieved cross party support

***[S6M-20773](#) Alexander Stewart: The Widening Health Inequalities Across Scotland**—That the Parliament notes its concern at what it sees as widening health and healthcare inequalities across Scotland, including in the Mid Scotland and Fife region; understands that, according to the Scottish Public Health Observatory, Scotland has wide socioeconomic inequalities in comparison with other Western European countries; believes that these are a major driver of the high and growing health inequalities, as measured by indicators such as life expectancy and mortality rates; considers that health inequalities in Scotland on some measures are continuing to widen; acknowledges that, with a reported life expectancy gap of up to 13 years for men and 10 years for women between the most and least deprived areas, what it sees as these unjust, systematic disparities are driven by socioeconomic factors, resulting in significantly lower healthy life expectancy and higher mortality rates for, among others, people in poverty, with drug-related deaths reportedly over 15 times higher in deprived areas; considers that, in the face of this challenge, local health centres and primary care infrastructure across Scotland are facing significant pressure, with numerous projects in need of urgent upgrading, expansion or replacement to meet the demands of growing communities and modern healthcare delivery, including the proposed £13 million new Lochgelly Health Centre and the planned £8 million Kincardine Health Centre, which are, it believes, facing severe delays and uncertainty despite reports of numerous calls on the Scottish Government to take action, and highlights factors such as health inequalities, population growth, an ageing population, new housing developments, service modernisation requirements and environmental standards, which are all, it believes, adding pressure to the requirement for updated healthcare infrastructure, which it considers will, in turn, improve patient outcomes and referrals, move care into communities and provide fit-for-purpose workspaces for vital multidisciplinary teams.

***[S6M-20769](#) Gillian Mackay: Recognising the Contribution that Football Clubs and their Fans Make to Society**—That the Parliament notes that football is one of the most loved and successful sports in the country and that Scotland boasts some of the most loyal supporters anywhere in Europe, but believes that, often, fans feel they are taken for granted or are an afterthought; considers that, across the country, including in the Central Scotland region, supporters groups and community trusts or charitable foundations attached to professional clubs are often enhancing their environment and giving back to those who find themselves in challenging situations, from foodbank collections to mental health initiatives; believes that football fans are often the beating heart of their communities,

creating unity in spaces where division can be prevalent; considers that, with rising living costs, varying ticket prices and high transport costs, the current landscape is making it difficult for working-class fans and families to afford to follow their club, an outlet, it believes, that allows hundreds of thousands of people across the country an escapism and a sense of optimism in a time of struggle; recognises that a price cap has been in place in England for over a decade and means that travelling fans do not pay more than £30 for a ticket, yet understands that no such cap exists at present in Scotland; notes the calls for all 42 Scottish Professional Football League (SPFL) clubs, as well as the Scottish Football Association (SFA) to put fans first; further notes the view that the voices of supporters should be heard by decision makers and amplified within the Scottish Parliament, and notes the belief that those running the national game should listen to the calls from the Scottish Supporters Collective and many fans across the country and cap away football ticket prices at £25.
