[S6M-20268](#) Alexander Burnett: Fair Share of Funding for Public Services—That the Parliament notes calls for fairer funding to be allocated among Scotland's 32 local authorities and 14 NHS boards; further notes reports that Aberdeenshire Council is the fourth lowest funded local authority in Scotland,

receiving less government funding per capita than the Scottish average; believes that NHS Grampian is the second lowest funded NHS board per head of population, is reportedly facing a deficit of nearly £50 million, has just 1.4 beds per 1,000 people, and has one of the fastest growing elderly populations in Scotland; considers that rural and island communities cover large geographical areas, which come with unique challenges and require significant resources, particularly with regard to infrastructure maintenance, service delivery and issues that arise from extreme weather; recognises concerns that local services are under immense pressure, and notes the view that it is important to ensure that communities are properly resourced to enable them to continue to have access to local services that meet their needs, including reliable public transport, local schools and health and social care services.

[S6M-20614](#) Bill Kidd: Justice for WASPI Women—That the Parliament condemns the latest decision by the UK Government regarding, and its continued refusal to compensate, the more than 3.5 million women affected by the acknowledged failures of the Department for Work and Pensions (DWP) to inform them of state pension age increases, despite the UK Government being made to reconsider its original refusal as a result of the recommendations of the Parliamentary Ombudsman, which called for compensation of between £1,000 and £2,950 for each of those affected; echoes the comments of the Women Against State Pension Inequality (WASPI) group, which said that the latest decision demonstrated "utter contempt" for those affected in the Glasgow Anniesland constituency and across the country, and notes the calls for the immediate reversal of what it sees as this shameful, immoral and inhumane decision.

***[S6M-20849](#) Jamie Halcro Johnston: Sustainability of Remote, Rural and Island Communities—**That the Parliament recognises a special duty to ensure the long-term sustainability of Scotland's remote, rural and island communities; notes the view that addressing the needs of these communities requires policy that recognises and accommodates the particular circumstances of the Highlands and Islands region and other parts of remote, rural and island Scotland; acknowledges the challenges of delivering public services such as education, transport, local health and social care, policing and justice to areas with lower population density; believes that a range of local public services have been centralised or downgraded and no longer have a visible presence in many remote and rural communities; considers that the rural economy and rural businesses have faced unprecedented challenges in recent years with the farming and fishing sectors under real pressure and uncertainty, increased regulation impacting the visitor economy, and high streets and town centres struggling; believes that access to housing and affordable accommodation has become increasingly difficult in these communities, particularly for young people; recognises what it sees as the vital importance of connectivity to the prosperity of these communities, including preserving and expanding travel links by road, rail, sea and air and the need to plan for the future investment needs of essential infrastructure, and notes the view that building strong communities in all parts of Scotland will require a greater focus and consideration from across Scotland's public bodies. **R**

***[S6M-20852](#) Willie Rennie: Motion of Condolence for Andrew Arbuckle MBE**—That the Parliament notes with great sadness the death of Andrew Arbuckle MBE, former Scottish Liberal Democrats MSP for Mid Scotland and Fife, who passed away peacefully on Christmas Day at the age of 81; understands that a memorial service will be held in St Andrews on 25 February 2026 to celebrate his life; recognises his long and distinguished career as a journalist, including four decades covering agriculture for *The Courier* and, later, *The Scotsman*, and for his service as a Fife councillor and MSP, where he was respected for his dedication to his constituents and his work on rural and community issues; honours his tireless contributions to the farming community, his fundraising efforts for the Royal Scottish Agricultural Benevolent Institution (RSABI), which raised more than £100,000, and his broader service to the community of Fife, for which he was appointed an MBE in the 2024 New Year Honours; acknowledges his wider civic engagement, including his leadership roles in local sports, community trusts and charitable initiatives, which enriched community life and secured lasting infrastructure and recreational facilities; extends heartfelt condolences to his family and friends, and expresses deep sympathy to all who mourn his passing, while celebrating a life of remarkable service, humour and generosity.

***[S6M-20851](#) Alex Rowley: Addressing the Crisis of Unmet Palliative Care Need**—That the Parliament welcomes the new national analysis from Marie Curie, Unmet Need for Palliative Care in Scotland; understands that this research uses a new methodology developed through the DUECare Project, involving King's College London, Hull York Medical School, and the University of Edinburgh; believes that the findings provide a more accurate baseline for the country, showing that almost one in three people in Scotland die with unmet palliative care needs; understands that according to this research, "unmet palliative care need" is measured as a person with life-limiting illness experiencing significant unaddressed symptoms or concerns alongside inadequate access to GP services; considers the report's findings that approximately 18,500 people in Scotland die each year without the support they require; believes that Scotland faces a widening gap between the care people need at the end of life and what the current system provides; considers that to bridge this gap, palliative care must be established as a right that can be realised, and notes the call that the next Scottish Government must commit to and legislate to deliver a Right to Palliative Care to ensure equitable, person centred support for all, and to drive sustainable resourcing of palliative care and incentivise investment in community care.

***[S6M-20848](#) Alex Rowley: Launch of the Social Action Inquiry Scotland's Policy Library**—That the Parliament welcomes the publication of the Social Action Inquiry Scotland's Policy Library, an innovative offering to Scotland's political parties ahead of the Scottish election in May 2026; understands that Social Action Inquiry Scotland brought together people from diverse communities across Scotland to discuss Scotland's future and to examine “what helps and what hinders social action”; notes that the social activism of these groups focuses on the different social, economic and cultural needs of the local population; believes that Scotland is rich in social action, from neighbours looking out for each other, to local groups running essential services and campaign groups working nationally and internationally, but that too often this happens in spite of the system, not because of it; understands that the launch of the library comes at a time when it considers that public services are being cut, budgets reduced, inequality is rising, the cost of living soaring and life expectancy falling; welcomes the extensive community-led Inquiry conducted by these communities and the innovative library of policies that cover a broad range of social justice issues, and urges the political parties and candidates standing for election to adopt the library's policies, which, it understands, are aimed at unlocking Scotland's potential to become a more compassionate country.
