S6M-20387 Liam McArthur: Future Farming Investment Scheme —That the Parliament acknowledges that the Future Farming Investment Scheme sought to provide farmers and crofters with funding to help them buy new machinery, improve efficiency or reduce emissions, and was targeted towards islanders, new entrants, young farmers and tenant farmers; understands that Orkney businesses initially received only 3.48% of total funding, and Shetland 1.88%; notes with concern reports that fewer than one in 10 small farms and crofters across Scotland received funding, with many small farms from the Highlands and Islands to Aberdeenshire, Argyll and Bute and the south of Scotland also missing out; believes that much of the communication around this scheme has caused confusion, and indeed anger, among those in the agricultural sector; expresses deep regret that, while demand for the scheme was high, so few small, island and young farmers were successful, despite seemingly being from priority groups, and notes the calls on the Scottish Government to provide further clarity on how the funding for the scheme was allocated, as well as to publish its review on the Future Farming Investment Scheme, as committed by the Cabinet Secretary for Rural Affairs and Islands on 10 December 2025.

***S6M-20515 Kevin Stewart: Recognising the Efforts of Craig Stirrat**—That the Parliament notes the announcement that Craig Stirrat, chief executive of Grampian Housing Association, will be retiring in Autumn 2026; recognises that Craig has been chief executive since April 2022, having first joined the organisation in 2014, during which time Grampian Housing Association has been accredited with Best Companies as an outstanding place to work and secured the Customer Service Excellence Standard thanks to the flagship Grampian Deal initiative; understands that Craig has spent over 40 years in the social housing sector, during which time he has served on the Chartered Institute of Housing in Scotland board, the UK HouseMark Board, the Scottish Advisory Board, and currently serves on the Board of the Scottish Federation of Housing Associations; further understands that Craig's lasting impact in the social housing sector led to him being awarded the Chartered Institute of Housing in Scotland's Lifetime Achievement award in 2023; believes that Craig can be rightly proud of the contribution he has made to social housing, nationally as well as locally, and hopes he enjoys his very well-earned rest when he steps down.

***S6M-20514 Alexander Stewart: Welcoming the Return of Central Safe Drive, Stay Alive for 2026**—That the Parliament welcomes the return of Central Safe Drive Stay Alive, which is set to take place from 26 to 30 January 2026, with S4 pupils from across the Mid-Scotland and Fife region travelling to Stirling's MacRobert Arts Centre; understands that 2025's performances saw 830 youngsters make it through from Clackmannanshire alone; notes that, during the annual event, students are shown a film depicting a typical road collision that involves young people and showing the potential impact of peer pressure, distraction and bad driving practices; further notes that members of the emergency services come on stage between segments and describe their role in the aftermath of the collision and that, after the film, family members of people who have been killed or experienced life-altering injuries give emotional testimonies on how their lives were suddenly and dramatically changed by a crash; acknowledges that there are significant financial challenges involved with running the programme; notes that organisers say that it has been effective, as road deaths and injuries have fallen over the 18 years that the shows have been running; believes that, with no government funding and small levels of local authority funding available, the team behind it must raise almost the full cost of the initiative every year to continue to offer the roadshow free of charge to every high school in the area; commends everyone involved in the production, including Alan Faulds, Melanie Mitchell and the production's sponsors, Air Products, who are in the final stages of building a state-of-the-art production plant in Alloa; notes that, in 2024-25, the costs of the building hire, bus hire and all the other associated factors were more than £30,000; considers, however, that, with an estimated cost of £1.8 million for every road death in Scotland, and an even higher cost for a lifetime of round-the-clock care, the education of young people makes financial sense, as well as working hard to avoid the devastation to families that occurs in the aftermath of a road traffic collision, and wishes everyone involved all the very best and every success with this year's production. **R**

As soon as a Public Bill (i.e. a Government, Committee or Member's Bill) has completed Stage 1, amendments for consideration at Stage 2 may be lodged; and as soon as Stage 2 is completed, amendments for Stage 3 consideration may be lodged. The last lodging day for amendments at Stage 2 is four sitting days before the meeting at which those amendments will be considered (e.g. Wednesday for a meeting on Tuesday); at Stage 3 it is five days before. Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for each Stage, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
