REVIEW OF REMOVAL: PROTECTION OF VULNERABLE GROUPS

Review of removal: protection of vulnerable groups

- (1) The Scottish Ministers must, before the end of the period of one year beginning with the day of Royal Assent, undertake a review on whether to introduce legislation making provision for removal of members of the Scottish Parliament where the member is—
 - (a) barred from regulated roles with children,
 - (b) barred from regulated roles with adults, or
 - (c) barred from both types of regulated role.
- (2) As soon as reasonably practicable after completing the review, the Scottish Ministers must prepare a report on the review under subsection (1).

- (3) A report under subsection (3) must be—
 - (a) published, and
 - (b) laid before the Scottish Parliament.
- (4) In subsection (1), “barred from regulated roles” has the meaning given by section 92 of the Protection of Vulnerable Groups (Scotland) Act 2007.>
