Members' Business motions that have not achieved cross party support

***[S6M-08977](#) Pam Gosal: Volunteers' Week**—That the Parliament recognises that Volunteers' Week takes place from 1 to 7 June every year; understands that the campaign began in 1984 and is now in its 39th year; acknowledges that the 2023 UK-wide Volunteers' Week theme is "Celebrate and Inspire"; acknowledges what it sees as the important role that volunteers play in communities during Volunteers' Week and all year round; believes that the week marks the ideal opportunity to thank the efforts of volunteers in communities across Scotland, and considers that volunteers are the backbone of the community, who support services and make a difference to people's lives.

***[S6M-08947](#) Audrey Nicoll: Increasing the Participation of Women and Girls in Science, Technology, Engineering and Maths**—That the Parliament believes that Science, Technology, Engineering and Mathematics (STEM) make an important contribution to driving economic growth and delivering new approaches to the climate emergency; notes the so-called leaky pipeline, whereby women and girls account for only 25% of the STEM sector, despite maths and science subjects being equally popular among girls and boys within school age education; recognises the work underway in schools and further and higher education institutions, including Robert Gordon University, located in the Aberdeen South and North Kincardine constituency, as well as in businesses and energy-related industries, to address the under-representation of women and girls in the STEM sector; welcomes the Scottish Government's STEM strategy and the work of Equate Scotland, which aim to change cultures in organisations and academia; commends Aberdeen City Council and its partners for what it sees as their innovative work to align the school curriculum to future skills demands in offshore energy production and other growth sectors, and notes the view that all stakeholders should continue to work together to increase opportunities for girls and young women in STEM.

***[S6M-08922](#) Colin Smyth: An Older People's Commissioner for Scotland**—That the Parliament notes the calls from organisations, including Age Scotland and Independent Age, for a new commissioner to champion the rights of older people in Scotland, to ensure that the long-term needs of people in later life are considered in policy and practice across government, that negative

stereotypes are challenged and that positive views of ageing and the contribution older people make to society are promoted; acknowledges projections that Scotland's population is continuing to age and that there will be a 50% increase in the over 60s by 2033; highlights that new statistics from the Scottish Government, published in March 2023, reveal that, in 2019-22, 15% of pensioners in Scotland, almost one in six, were living in relative poverty after housing costs, compared with 14% in the previous period; believes that the COVID-19 pandemic had a profound impact on older people, including in the South Scotland region; notes the view that this demonstrates more than ever the need to give older people a strong, independent voice to reflect their views and experiences and protect and promote their human rights; further notes that all four nations of the UK now have commissioners for children; understands that Wales and Northern Ireland already have commissioners who are improving the lives of older people, and that the campaign for a commissioner for England is reportedly growing all the time, and notes the calls for the Scottish Government to investigate the need for an independent commissioner to support the interests, and amplify the voices, of older people in Scotland.

***[S6M-08884](#) David Torrance: Volunteers' Week 2023**—That the Parliament acknowledges the 39th annual Volunteers' Week, which runs from 1 to 7 June 2023, with the theme of "Celebrate and Inspire"; notes figures from the 2021 Scottish Household Survey, which show that 27% of Scotland's adult population volunteered for an organisation or group in the previous 12 months; further notes estimates that volunteering contributes £5.5 billion annually to Scotland's economy; believes that volunteers make fundamental contributions in communities across the country, including in Kirkcaldy, and that the survival and success of many groups and charities is dependent on the dedication and hard work of those who commit their time and special skills to help others in need; considers that many people face challenges as a result of the COVID-19 pandemic; believes that volunteers deserve recognition, respect and appreciation for what it sees as their critical efforts in supporting and rebuilding communities, and thanks them for their commitment and dedication.

***[S6M-09058](#) Brian Whittle: Killie Heartmates Celebrate 25 Years**—That the Parliament welcomes the news that Killie Heartmates are celebrating their 25th anniversary in May 2023; notes that Killie Heartmates are now in their 27th year of operation and that their celebration was unfortunately postponed due to the COVID-19 pandemic; understands that Killie Heartmates are an active cardiac exercise group, with fully qualified BACPR instructors, which formed in 1996 to provide a keep-fit class for people from all age groups who have experienced cardiac events, and that the group is affiliated with Chest Heart & Stroke Scotland; further understands that the group also operates social outings for participants, along with their family and friends; recognises the efforts of John and Sheena Thomson, who established the group to help serve the needs of the Crosshouse Hospital community, beyond the cardiac rehabilitation and physiotherapy services provided through the NHS, while retaining a close working relationship with the Crosshouse Cardiac Rehabilitation Unit and East Ayrshire Council's Vibrant Communities team; further recognises what it sees as the value of third sector organisations in supplementing, or bridging the gap between, public services; commends Killie Heartmates on their commitment to meeting safely when they were able to return to classes in April 2021 by completing thorough risk assessments, which it understands made them the first cardiac rehab group in Scotland to return safely to outdoor classes; applauds the dedication and success of the Killie Heartmates Committee and members, and wishes them well in all their future endeavours.
